BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

Section 1. That an ordinance heretofore passed the City Council to install a loading zone on portions of designated street, be and the same is hereby amended by striking the following:

30 minute loading zone located adjacent to 61 East Superior Street (south curb)—unattended vehicles must have lights flashing—tow-away zone after 30 minutes— tow-away zone and inserting in lieu thereof

Loading Zone- tow-away zone

Section 2. This ordinance shall take effect and be in force hereinafter its passage and publication.

- o Vehicles parking in standing zones for more than 15 minutes are subject to citation and towing
- o Posting signage, whether on the standing zone sign or in the public way, to claim ownership of a standing zone is not permitted per Chicago Municipal Code
