ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-3 Neighborhood Commercial District symbols and indications as shown on Map No. 15-G in an area bound by:

North Broadway; the alley next north of and parallel to West Thorndale Avenue; the alley next east of and parallel to North Broadway; and a line 75 feet north of and parallel to West Thorndale Avenue.

To those of a B1-3 Neighborhood Shopping District.

SECTION 2. This ordinance takes effect after its passage and due publication.
