WHEREAS, By ordinance passed by the City Council on November 17, 2010 for the 2011 fiscal year, the City Council authorized the projected use of Community Development Block Grant entitlement funds for Year XXXVII (the "Year XXXVII CDBG Ordinance"); and

WHEREAS, Pursuant to the Year XXXVII CDBG Ordinance, the reprogramming of funds is subject to review and approval by the City Council; and

WHEREAS, The City, through its Department of Family and Support Services ("DPSS"), desires to reallocate \$149,000 of Year XXXVII CDBG funds from the Department of Housing and Economic Development (DHED) 2515. 9103 Rehabilitation and Loans and Grants program to be used to support delegate agency programs in DFSS -Youth Service Program, Senior Services, Workforce Services Program and DCD - Housing Technical Assistance Program ; and

WHEREAS, The City desires to amend the Year XXXVII CDBG Ordinance to account for the above-described funding reallocations; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The Year XXXVII CDBG Ordinance, as amended, is hereby further amended by adding the underscored words and figures, and deleting the struck-through words and figures, shown on Exhibit A attached hereto.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval.
