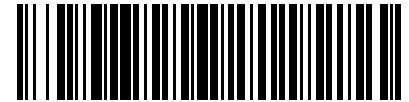

**Title:** Call for Department of Assets, Information and Services to enter into one-year extended franchise agreement with Commonwealth Edison Company (ComEd)

ORDER

**WHEREAS**, the Ordinance and Agreement Between the City of Chicago and Commonwealth Edison Company ("ComEd") effectively January 1, 1992 ("the Franchise Agreement") formally expires on December 31, 2020 thus requiring its extension or renegotiation of the franchise; and,

**WHEREAS**, Section 5 of the Franchise Agreement and the Illinois Municipal Code (65 Ill. Comp. Stat. 5/11-117-1), permits municipal acquisition of the utility facilities of ComEd at any time during the term of agreement; and,

**WHEREAS**, the City of Chicago ("the City") is currently completing a feasibility study of the municipal acquisition of ComEd pursuant to Order 2019-272; and,

**WHEREAS**, the City Council of the City of Chicago, and the residents and businesses of the City, will benefit from public hearings of the results of the feasibility study of the municipal acquisition of ComEd; and,

**WHEREAS**, the City's negotiating position with ComEd will benefit from public hearings of the results of the aforementioned feasibility study; and,

**WHEREAS**, the COVID-19 pandemic transformed City operations to such an extent that the City will not benefit from negotiating a lengthy franchise agreement with ComEd.

**NOW BE IT ORDERED**, the Department of Assets, Information and Services shall enter into a one-year extension of the ComEd Franchise Agreement, pursuant to Section 3.3 of the existing Franchise Agreement.
