WHEREAS, Richard met his wife Liduvina “Lilly” (Mercado) Urquhart at the age of 33 on a blind date to a dance, which led to the wedding 2 years later on June 25th, 1966; They welcomed their first-born child William Joseph Urquhart on July 22nd, 1967 (deceased), followed by their daughter Margaret Teresa Urquhart Kishta on April 14th, 1972, followed by a granddaughter Amanda Marie Urquhart on October 11th, 1992; and

WHEREAS, Richard is survived by his wife Liduvina (Mercado) Urquhart, a daughter Margaret Teresa (Belal) Urquhart Kishta and a granddaughter Amanda Marie Urquhart; and


