Section 1:

The ordinance passed by the City Council of the City of Chicago for **WRIGLEYVILLE WILD WINGS** on **04/22/2009**, and printed upon page **59351** of the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words

“Seven (7) canopies over the public way

Said canopies shall not exceed one (1) @ sixteen (16) feet in length and eight (8) feet in width, one (1) @ four point five (4.5) feet in length and two (2) feet in width, one (1) @ six (6) feet in length and two (2) feet in width and one (1) @ six (6) feet in length and four (4) feet in width.

The sum of \$350.00 per annum, in advance.”

and inserting in their place the words


“Three (3) canopies over the public way
