BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

West Ogden Avenue; a line to the north 743.85 feet along South Kenneth Avenue; a line 292.68 feet perpendicular to South Kenneth Avenue; a line to the south 129.94 feet on the east side of vacated South Kilbourn Avenue; a line extending 78.23 feet southwest across vacated South Kilbourn Avenue; a line 563.24 feet extending west perpendicular to South Kenneth Avenue; a line to the south 521.13 feet; a line to the southeast 119.26 feet; a line to the south 213.77 feet; a line to the southeast 88.22 feet

to those of a M2-2 Light Industry District.

**SECTION 2.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M2-2 Light Industry District symbols and indications as shown on Map No. 6-K in the area bounded by

West Ogden Avenue; a line to the north 743.85 feet along South Kenneth Avenue; a line 292.68 feet perpendicular to South Kenneth Avenue; a line to the south 129.94 feet on the east side of vacated South Kilbourn Avenue; a line extending 78.23 feet southwest across vacated South Kilbourn Avenue; a line 563.24 feet extending west perpendicular to South Kenneth Avenue; a line to the south 521.13 feet; a line to the southeast 119.26 feet; a line to the south 213.77 feet; a line to the southeast 88.22 feet

to those of a Planned Development District.

Dear Property Owner:

J.B. Hunt Transport, Inc., a Georgia corporation, (“J.B. Hunt”) is applying to the City of Chicago to secure a site-specific zoning ordinance called a “planned development” for the captioned Property. The planned development will allow J.B. Hunt to construct a facility for storage of containers, trailers, and trucks at the Property.

This letter is your notice about J.B. Hunt’s application to amend the zoning classification of the Property, first for a portion of the Property from M1-2 Limited Manufacturing/Business Park District to M2-2 Light Industry District, and then for the entirety of the Property to a planned development. The Chicago Zoning Ordinance requires the applicant to send this notice (Municipal Code of Chicago Title 17, Section 17-13-0107).

On or about May 30, 2012, the law firm of Reyes Kurson will file an application to amend the zoning classification of the Property. We anticipate that the application will be submitted to the City Council on May 30, 2012. The Chicago Plan Commission and City Council Committee on Zoning will hold hearings about the proposed planned development.

Please note that J.B. Hunt is not seeking to rezone or purchase your property. J.B. Hunt is required to send this letter to you because you are the taxpayer of record (the owner) of property within 250 feet of the Property.

The Property is currently owned by Freeport-McMoran Chicago Rod Inc., a Delaware corporation, which has its principal place of business at 333 North Central Avenue, Phoenix, Arizona 85004. The applicant is J.B. Hunt; the principal place of business for the company is 615 J.B. Hunt Corporate Drive, Lowell, Arkansas 72745.

## PLANNED DEVELOPMENT STATEMENTS

1. The area delineated herein as Institutional Planned Development Number \_\_\_\_\_, consists of property commonly known as 4434 - 4548 West Ogden Avenue and 2304 - 2410 South Kenneth Avenue, Chicago, Illinois ("Property"). The Property consists of a net area of 16.73 acres (728,895 square feet) and gross site area of 10.6 acres (896,941 square feet). The Property is under contract to and will be owned by and will remain under the unified control of J.B. Hunt Transport, Inc., a Georgia Corporation or its assigns ("Applicant").

2. All applicable additional reviews, approvals or permits will be obtained by the Applicant or its successors, assignees, or grantees. Any dedication or vacation of streets, alleys, easements, adjustments of rights-of-way, or consolidation or re-subdivision of parcels, shall require a separate submittal on behalf of the Applicant or its successors, assignees, or grantees, and shall require a separate approval by the City Council.

3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustments of the rights-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assignees or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Housing and Economic Development and Transportation. Closure of all or any public street or alley during demolition or

construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

4. This plan of development consists of fifteen (15) statements; a Bulk Regulations and Data Table; an Existing Zoning Map; an Existing Land-Use and Street Map; a Planned Development Boundary and Property Line Map; two Site Plans for each phase of construction; a Landscape Plan; Floor Plans and Building Elevations prepared by Watermark Engineering Resources, Ltd., dated June 6, 2012. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

5. The following uses shall be permitted within the planned development: storage of containers, trailers and trucks; maintenance of containers, trailers and trucks; stacking of containers; and all non-residential uses otherwise permitted or allowed by special use in the M2-2 Light Industry District.

6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Housing and Economic Development. Off-Premise signs are prohibited within the boundary of the Planned Development.

7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.

8. The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance with the attached Bulk Regulations Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of 16.73 acres (728, 895 square feet).

9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Housing and Economic Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.

10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Housing and Economic Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.

11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Environment and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.

12. Prior to the Part II Approval (per Section 17-13-0610 of the Zoning Ordinance) for Phase 2, the Applicant shall submit a site plan, landscape plan and building elevations

for review and approval by the Department of Housing and Economic Development. Review and approval by the Department of Housing and Economic Development is intended to assure that specific development components substantially conform with the Planned Development and to assist the City in monitoring ongoing development.

No Part II Approval, other than for foundation permits, for any portion of the Phase 2 plans for the Property shall be granted until Phase 2 Site Plan approval has been granted. If the Phase 2 Site Plan Approval submittals substantially conform to the provisions of the Planned Development, the Department of Housing and Economic Development shall approve the submittal within 30 days of receipt of a complete set of Phase 2 Site Plan Approval submittals. Following approval by the Department of Housing and Economic Development, the approved Site Plan Approval submittals, supporting data and materials shall be made part of the main file and shall be deemed to be an integral part of the Planned Development.

After approval of the Phase 2 Site Plan, changes or modifications may be made pursuant to the provisions of this planned development. In the event of any inconsistency between approved plans and the terms of the Planned Development, the terms of the Planned Development shall govern. Any Site Plan Approval Submittals shall, at a minimum, provide the following information:

- fully-dimensioned site plan (including a footprint of the proposed improvements);
- fully-dimensioned building elevations;
- fully-dimensioned landscape plan(s); and,
- statistical information applicable to the subject Sub-Area, including floor area, the applicable FAR, uses to be established, building heights and setbacks.

Site Plan Approval Submittals shall include all other information necessary to illustrate substantial conformance to the Planned Development.

The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to section 17-13-0611-A of the Zoning Ordinance, by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.

13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.

14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources.

15. This Planned Development shall be governed by Section 17-13-0612 of the Zoning Ordinance. Should this Planned Development ordinance lapse, the Commissioner of the Department of Housing and Economic Development shall initiate a Zoning Map Amendment to rezone the property to M2-2 Light Industry District.

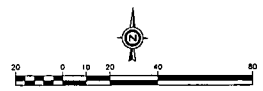

 PLAN-PHASE 1**



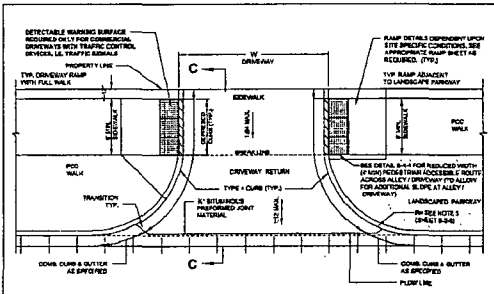
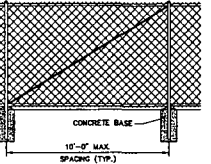
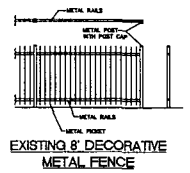
