ORDINANCE

WHEREAS, the Annual Appropriation Ordinance for the year 2021 (the "2021 Appropriation Ordinance") of the City of Chicago (the "City") contains estimates of revenues receivable as grants from agencies of the state and federal governments and public and private agencies; and

WHEREAS, the City through its Office of Budget and Management ("OBM") has been awarded federal COVID-19 carryover grant funds in the amount of \$20,100,000 by the United States Department of Housing and Urban Development for the Community Development Block Grant ("CDBG") program and desires to redistribute the grant funds from OBM to the City's Department of Assets, Information and Services in the amount of \$4,000,000, the Department of Public Health in the amount of \$5,000,000, and the Department of Business Affairs and Consumer Protection in the amount of \$11,100,000, which shall be used for various programs under the CDBG program; and

WHEREAS, the City through its Department of Aviation has been awarded additional federal COVID-19 grant funds in the amount of \$87,453,000 by the United States Department of Transportation for the Airport Assistance – COVID program, out of which Chicago Midway International Airport ("MDW") will receive grant funds in the amount \$18,696,000 and Chicago O'Hare International Airport ("ORD") will receive grant funds in the amount of \$68,757,000; now, therefore.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The amount of \$87,453,000 not previously appropriated, representing new grants is hereby appropriated from Fund 925 - Grant Funds for the year 2021. The 2021 Annual Appropriation Ordinance is hereby amended by striking the words and figures and adding the words and figures indicated in the attached Exhibit A which is hereby made a part hereof.

SECTION 2. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 3. This ordinance shall be in full force and effect upon its passage and approval.
