ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single–Unit (Detached House) District symbols as shown on Map No. 20-J in the area bounded by:

West 79th street; a line 36.38 feet West of and parallel to South Trumbull Avenue; the public alley next south of and parallel to West 79th Street; a line 72.38 feet West of and parallel to South Trumbull Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and approval.
