ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

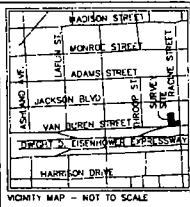
SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-3 Limited Manufacturing/Business Park District and B3-5 Community Shopping District symbols and indications as shown on Map No. 2-G in the area bounded by

West Gladys Avenue; a line 123.43 feet west of and parallel to South Racine Avenue; a line 70.21 feet north of and parallel to West Van Buren Street; South Racine Avenue; West Van Buren Street; and a line 222.71 feet west of and parallel to South Racine Avenue,

to those of a DS-5 Downtown Service District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

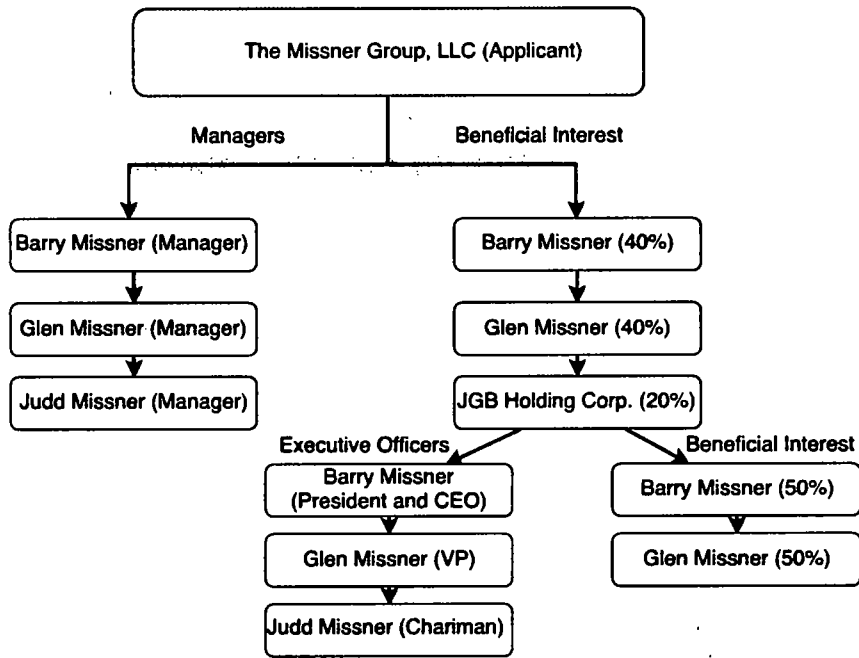

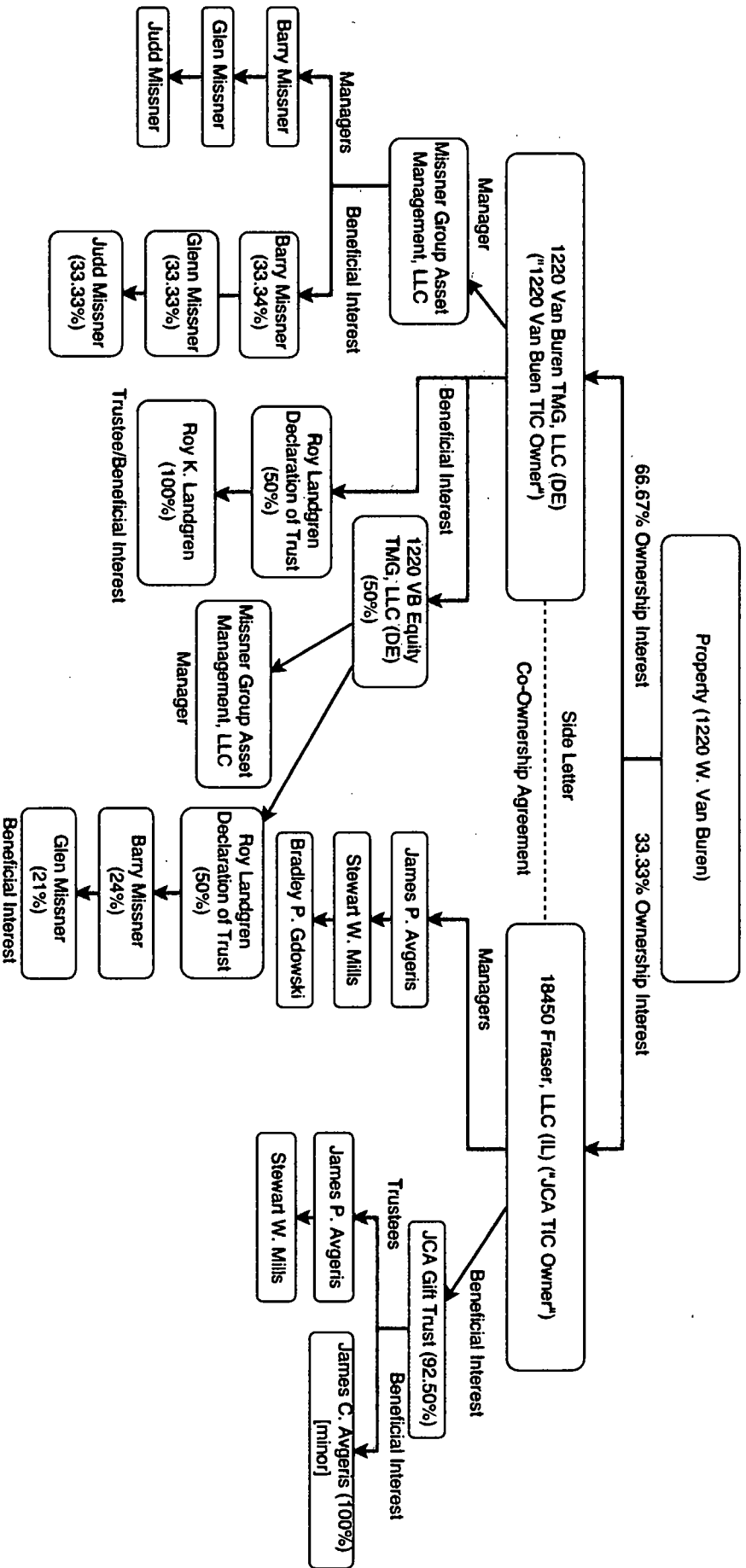
