ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 13-G in the area bounded by

a line 49.25 feet south of and parallel to West Balmoral Avenue; North Broadway; a line 74.25 feet south of and parallel to West Balmoral Avenue; and the alley next west of and parallel to North Broadway,

to those of a B3-3 Community Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



12. Reason for rezoning the property: The Applicant is seeking to amend the zoning at the subject property in order to locate and establish a full-service restaurant, with rooftop patio, at the site.

The purpose of the zoning change is to establish a business use (restaurant) at the site. The existing one-story, commercial, building will remain. The Applicant will also be constructing a rooftop deck (1,328.7 sq. ft.), at the east end of the existing building. The proposed rooftop deck will provide a full-service bar and additional seating for the restaurant.
