

WHEREAS, It is necessary and advisable to correct said errors in said Exhibits A and B; now, therefore,

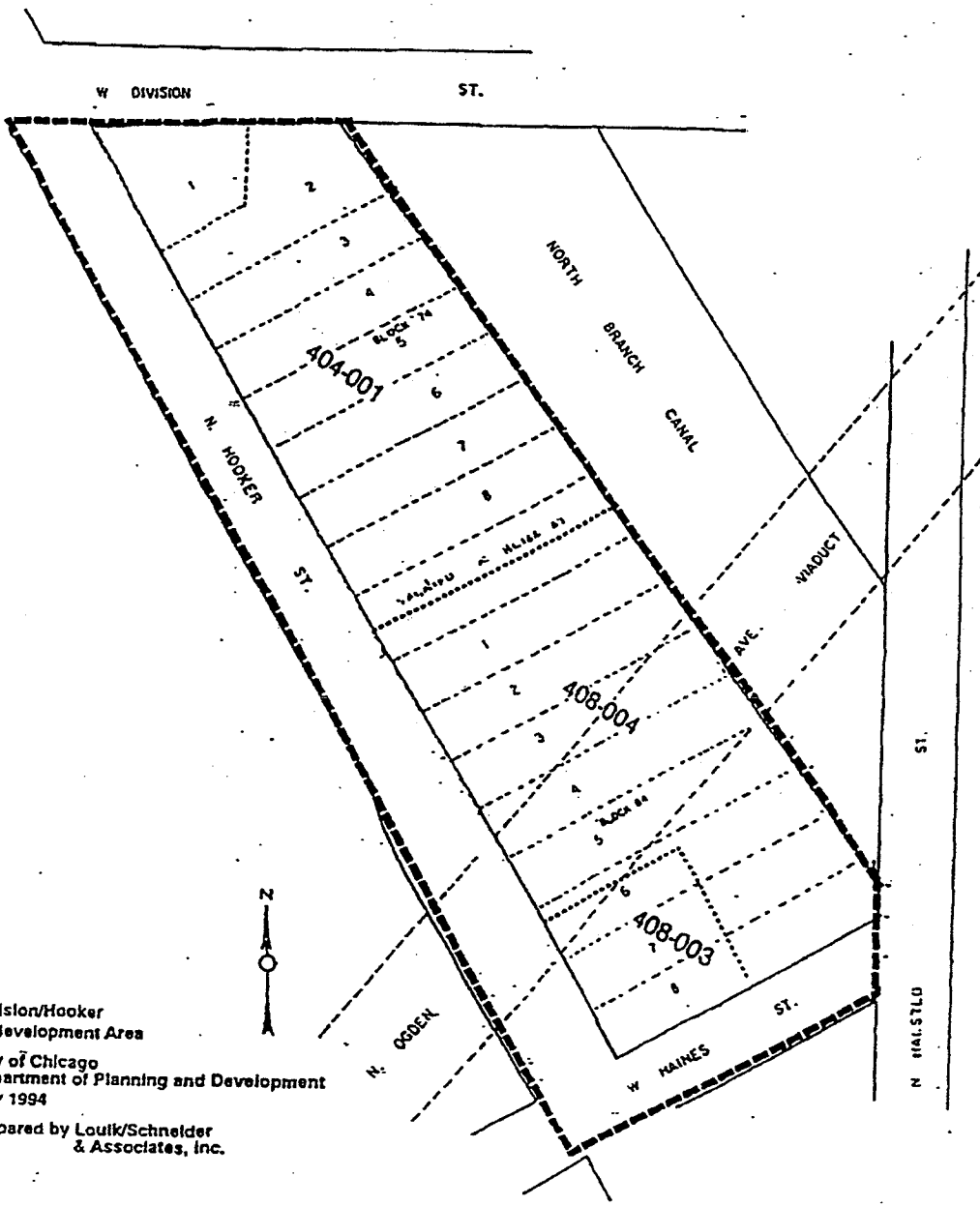
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:
