LABRIOLA BAKERY CAFE

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to LABRIOLA BAKERY CAFE, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use seven (7) Exhaust Duct(s) projecting over the public right-of-way adjacent to its premises known as 535 N. Michigan Ave.. Said exhaust ducts shall consist of heating and ventilation.

Said Exhaust Duct(s) at PUBLIC ALLEY measure(s):

One (1) at one point five (1.5) foot in length, and eighteen (18) feet in height.. Said exhaust duct shall be eighteen (18) feet ten (10) inches above grade level.

One (1) at three point five (3.5) feet in width and twenty (20) feet in height.. Said exhaust duct shall be eighteen (18) feet ten (10) inches above grade level.

One (1) at four (4) feet in width and twenty-one (21) feet in height. Said exhaust duct shall be seventeen (17) feet six (6) inches above grade level.

One (1) at twenty-one (21) feet in width and twenty (20) feet in height. Said exhaust duct shall be seventeen (17) feet six (6) inches above grade level.

One (1) at nineteen (19) feet in width and twenty-two (22) feet in height. Said exhaust duct shall be fifteen (15) feet six (6) inches above grade level.

One (1) at five (5) feet in width and thirteen (13) feet in height. Said exhaust duct shall be twenty-five (25) feet above grade level.

One (1) at three point three three (3.33) feet in width and eighteen (18) feet in height. Said exhaust duct shall be nineteen (19) feet seven (7) inches above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1114297 herein granted the sum of two thousand eight hundred (\$2,800.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

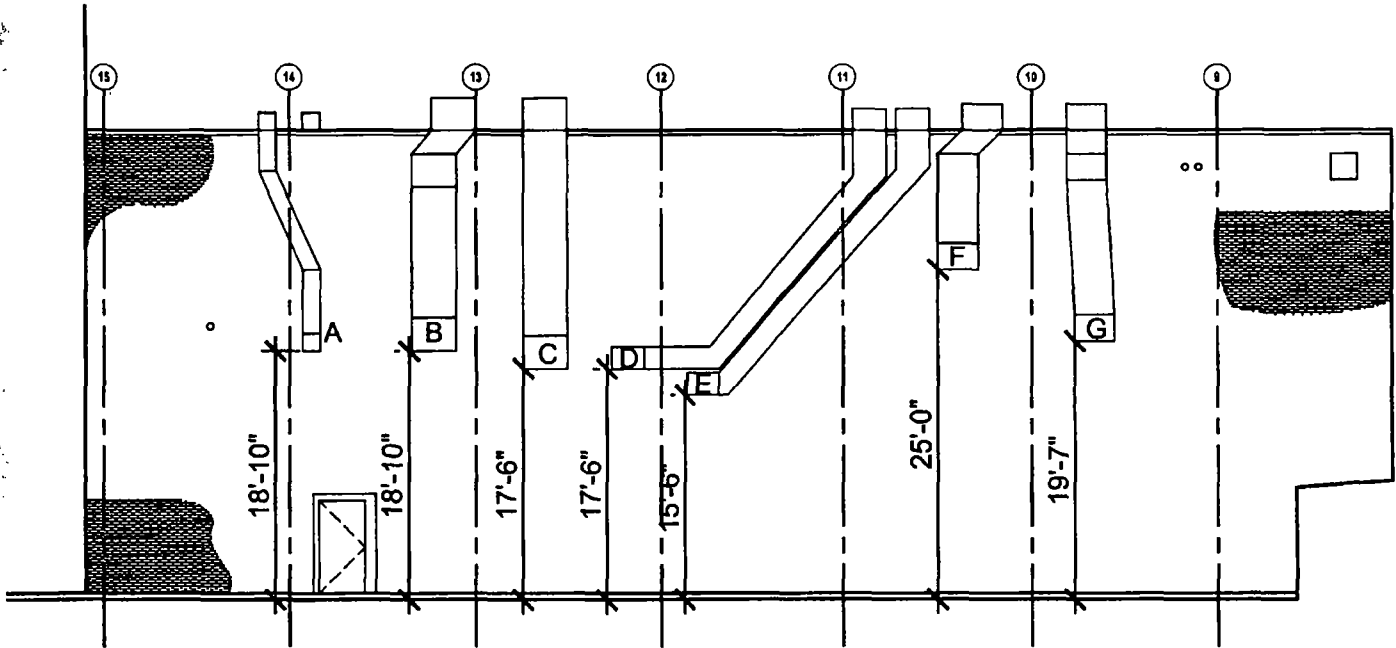

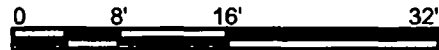
