BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District shown on Map No. 11-I in the area bounded by

West Lawrence Avenue; a line 133 feet east of and parallel to North Maplewood Avenue; the public alley next south of and parallel to West Lawrence Avenue; a line 58 feet east of and parallel to North Maplewood Avenue

to those of a B3-3 Community Shopping District.
