**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 District symbols and indications as shown on Map No. 1 - G in the area bounded by:

the public alley next south of and parallel to West Ohio Street; the public alley next east of and parallel to North May Street; a line 29.43 feet south of and parallel to the public alley next south of and parallel to West Ohio Street, North May Street.

to those of the B2-2 District

SECTION 2. This ordinance takes effect after its passage and approval.

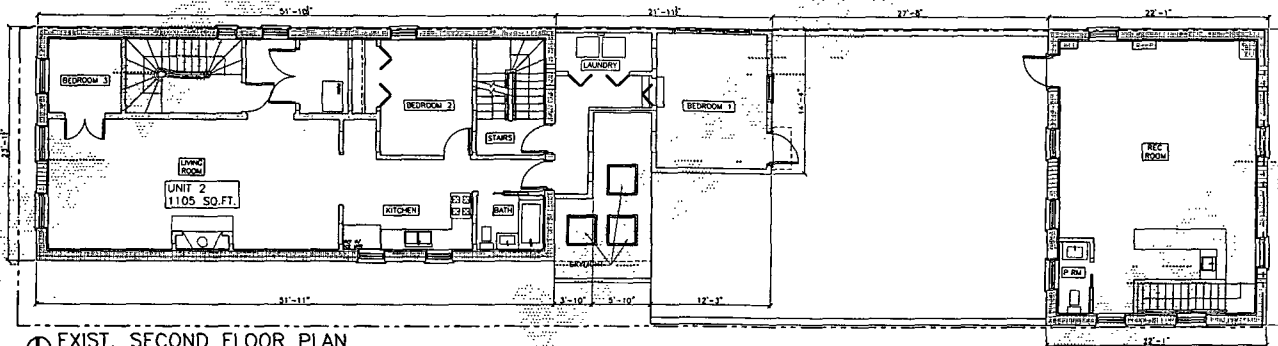

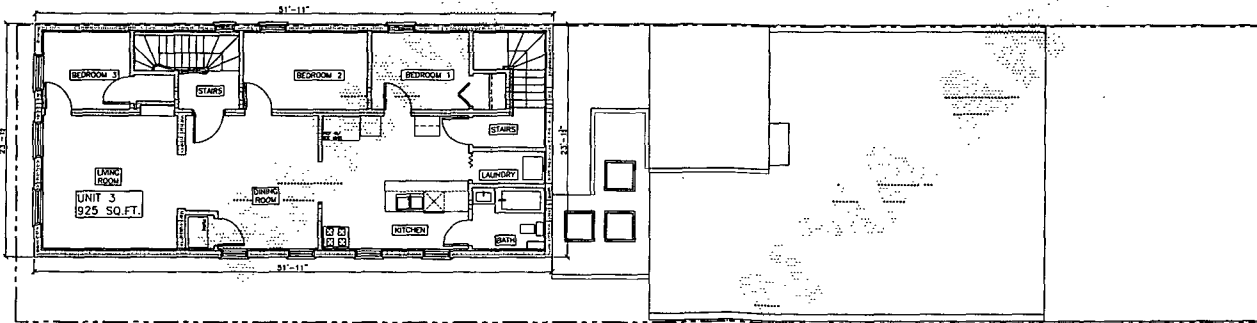

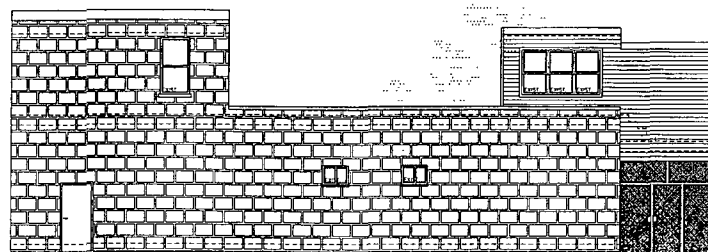
EXIST. WEST ELEVATION

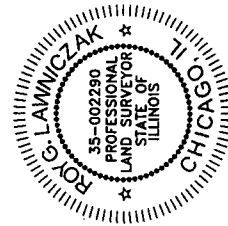
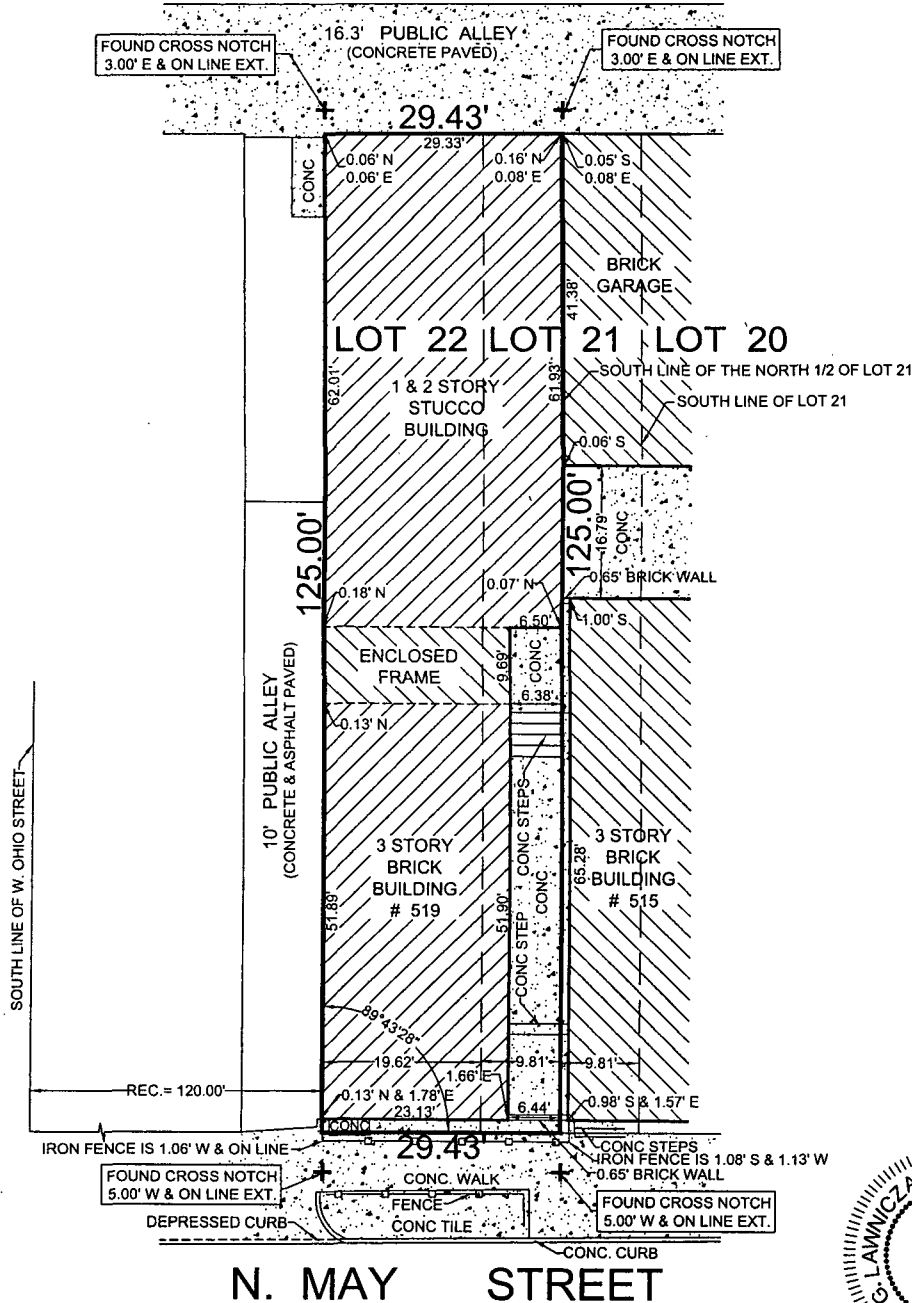
