

ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois authorized to exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the Cook County Board of Commissioners has enacted the Real Property Assessment Classification Ordinance, as amended (the "Classification Ordinance"), which establishes the Class 7c property tax; and

WHEREAS, 5657 Broadway LLC, an Illinois limited liability company ("Broadway"), intends to purchase certain real estate located generally at 6016-6060 North Western Avenue, 6045 and 6101 North Artesian Avenue, Chicago, Illinois 60659, as further described on Exhibit A hereto (the "Project Site"); and

WHEREAS, Broadway proposes to develop the Project Site by constructing an approximately 198,417 square foot building (the "Project"); and

WHEREAS, the Project will increase employment opportunities, economic activity in the area and growth in the real property tax base; and

WHEREAS, it is anticipated that Michael Robert Enterprises Inc. d/b/a Chicago Northside Toyota will lease the Project Site from Broadway when the Project is complete; and

WHEREAS, Broadway has applied to the Office of the Assessor of Cook County, Illinois (the "Assessor") for designation of the Project Site as a Class 7c classification eligible for certain real estate tax incentives; and

WHEREAS, the Classification Ordinance provides that an applicant for Class 7c classification must obtain an ordinance or resolution from the municipality in which the real estate is located expressly stating that (a) the municipality has determined that the eligibility factors of the Classification Ordinance are present, and (b) the municipality supports and consents to the Class 7c classification by the Assessor; and

WHEREAS, the Department of Planning and Development of the City ("DPD") has reviewed the proposed Project, has determined that it meets the necessary eligibility requirements for Class 7c designation, and hereby recommends to the City Council that the City amend the Prior Ordinance to expressly determine that (a) the required eligibility factors are present, and (b) the City supports and consents to the Class 7c classification by the Assessor of the Project Site; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are hereby expressly incorporated as if fully set forth herein.

SECTION 2. The City hereby determines that the Project meets eligibility factor (1) under the Classification Ordinance in that real estate taxes in the area for three of the last six years have either declined or remained stagnant due to the depressed condition of the area.

- SECTION 3. The City hereby determines that the Project meets eligibility factor (2) under the Classification Ordinance in that there is a reasonable expectation that the development, re-development or rehabilitation of the Project is viable and likely to go forward on a reasonably timely basis if granted Class 7c designation and will therefore result in the economic enhancement of the property.
- **SECTION 4.** The City hereby determines that the Project meets eligibility factor (3) under the Classification Ordinance in that certification of the Project Site for Class 7c designation will materially assist development, redevelopment or rehabilitation of the property and the Project would not go forward without the full incentive offered under Class 7c.
- **SECTION 5.** The City hereby determines that the Project meets eligibility factor (4) under the Classification Ordinance in that certification of the Project Site for Class 7c designation is reasonably expected to ultimately result in an increase in real property tax revenue and employment opportunities of the property.
- **SECTION 6.** The City hereby expressly determines that eligibility factors (1) through (4) under the Classification Ordinance are present for the Project, and hereby expressly supports and consents to the Class 7c designation by the Assessor of the Project Site.
- **SECTION 7.** The Commissioner of DPD (the "Commissioner"), or a designee of the Commissioner, are each hereby authorized to deliver a certified copy of this ordinance to the Assessor and to furnish such additional information as may be required in connection with the Class 7c designation of the Project Site.
 - **SECTION 8.** This ordinance shall be effective from and after its passage and approval.
