ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the **RS-3 Residential Single-Unit District**, as shown on Map 1-H in the area bounded by:

A line 119.80 east of North Wolcott Avenue, West Race Avenue, a line 215.64 feet east of North Wolcott Ave., and the alley north and parallel to West Race Avenue.

To those of RT-4 Residential Two-Flat, Townhome and Multi-Family District.

SECTION 2. This ordinance takes effect after its passage and approval.



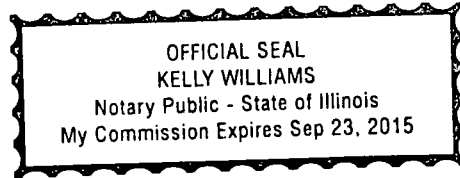

ATTACHMENT A

NARRATIVE DESCRIPTION FOR THE PROPOSED REZONING AT 1838-1846 WEST RACE AVENUE

In compliance with the "Type 1" rezonings requirements, the following Narrative is provided concerning the application to change zoning for 1838-1846 West Race Avenue, Chicago, Illinois from RS-3 to RT-4:

Floor Area Ratio:

The floor area ratio for RS-3 is .9 FAR. The proposed change to RT-4 would allow for a 1.2 FAR. The proposed single-family homes will be less than the maximum FAR permitted.

Density, Lot Area per Dwelling Unit:

The existing lot area for RS-3 is 2,500 square feet per Dwelling Unit. The lot area for RT-4 is 1,000 square feet minimum lot area per lot.

Off-street Parking:

For RT-4, Residential Two-Flat, Townhouse and Multi-Unit District, one off-street parking space is required for each Dwelling Unit. There will be two (2) garage spaces for each home at 1838-1846 West Race Avenue.

Setbacks:

All R Districts require a front yard setback to be a distance equal to the average of the front yard depth that exists on the nearest 2 lots on either side of the subject lot or 20 feet whichever is less.

The average of the front yard depth on each side of this property is 15.2 feet; however, Applicant is requesting a front yard setback of 13 feet under an administrative adjustment since this property is non-standard at only 108 feet deep.

The rear yard setback for the R Districts requires a minimum rear setback for principal buildings other than detached houses to be 30% of the lot depth or 50 feet, whichever is less. The rear yard setback for this property will be 32.5 feet, and therefore in excess of the required 30% of lot depth.

The side yard setbacks for the R Districts require that a combined total width must equal 20% of lot width with neither required setback less than 2 feet or 8% of the lot width, whichever is greater. Nonetheless, a 2' 6" setback is provided on the west side of the property and a 2' 5" foot setback is provided on the east side of the property.

Building Height:

The height limit for the RS-3 District is 30 feet. The height limit in the RT-4 District is 38 feet.
