to those of a RS3 Residential Single-Unit (Detached House) District and a corresponding uses district is hereby established in the area above described.

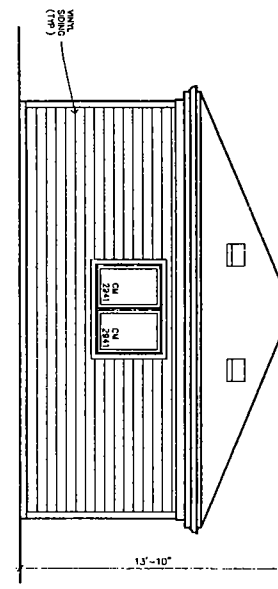
GARAGE PLAN

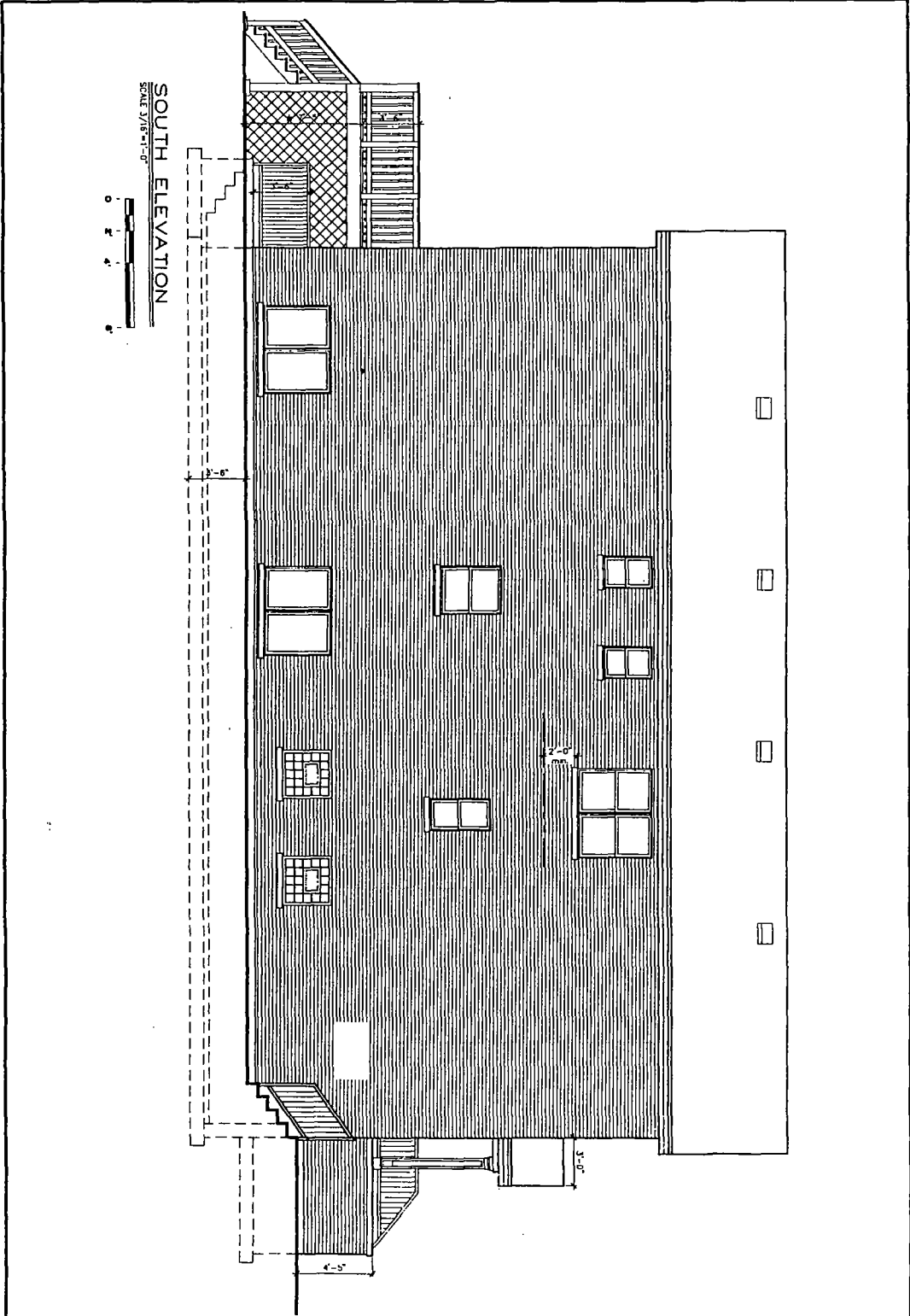
REAR ELEVATION
