*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to TOPPERS PIZZA, upon the terms and subject to the conditions of this ordinance to maintain and use two (2) sign(s) projecting over the public right-of-way attached to its premises known as 2428 N. Lincoln Ave..

Said sign structure(s) measures as follows; along N Lincoln Ave:

One (1) at nine point three four (9.34) feet in length, one point seven five (1.75) feet in height and twelve (12) feet above grade level.

One (1) at eight point eight four (8.84) feet in length, one point two five (1.25) feet in height and twelve (12) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1119043 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

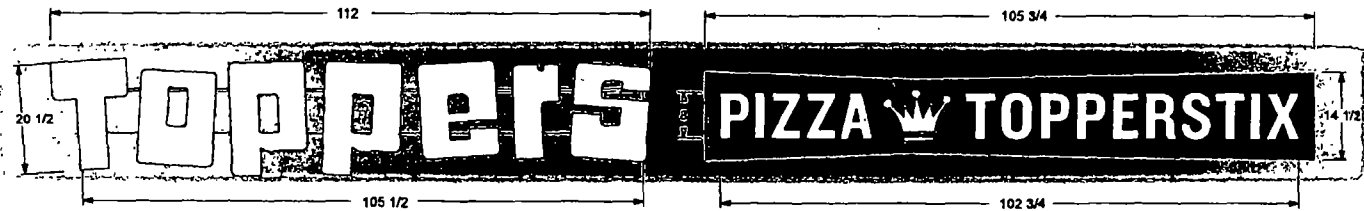

- Scope of Work : Manufacture and install (1) sign as shown
- Letters : Routed .080" aluminum backs, .040" x 5" tall returns, flanged & crimped construction
- Colors : Letter interiors prefinished White, returns prefinished Whisco "Black"
- Faces : Routed 1/8" "White" acrylic (#7328), 3/4" Jewelite "Black" trimcap
- Raceways : (Qty 2) SignComp (8" Narrow), extruded aluminum, internal mounting brackets, ( 105 1/2" & 109" Lengths ) exteriors primed and painted to match wall color (Sherwin Williams xox)
- Tagline Face : Routed .090" aluminum, .090" x 5" returns, returns welded to backside of face, exterior along with face painted "Black", interior painted white, tagline copy and crown to be 3/4" routed clear "Push-Thru" individual acrylic letters, faces covered with overlay of Gerber translucent White vinyl, "Crown" to have additional layer of Gerber translucent "Cardinal Red" (230-53) vinyl border, all backs covered with white light diffuser vinyl, letters installed from backside using studs welded to rear of face (studs welded to backside of face prior to welding of returns) back painted xox to match raceways.
- Lighting : Letters and cabinet internally-lit using white LED modules.
- Electrical : 120 volt, UL listed & labeled, power supplies in raceways
- Location : Sign centered left to right & up and down on signband of building
