SECTION 2. This ordinance shall be effective upon passage and approval.

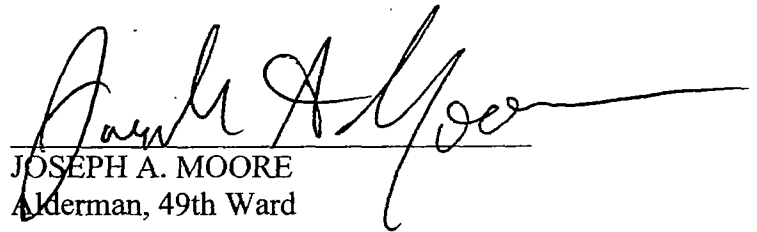
