***WHEREAS***, A man committed to excellence who maintained a high level of integrity, the Honorable Michael Oxley gave of himself fully to his family and was a loyal friend to many; and

***WHEREAS***, The Honorable Michael Oxley inspired the lives of countless people through his great personal goodness, charity and concern; and

***WHEREAS***, The hard work, sacrifice and dedication of the Honorable Mike Oxley serve as an example to all; and


