BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

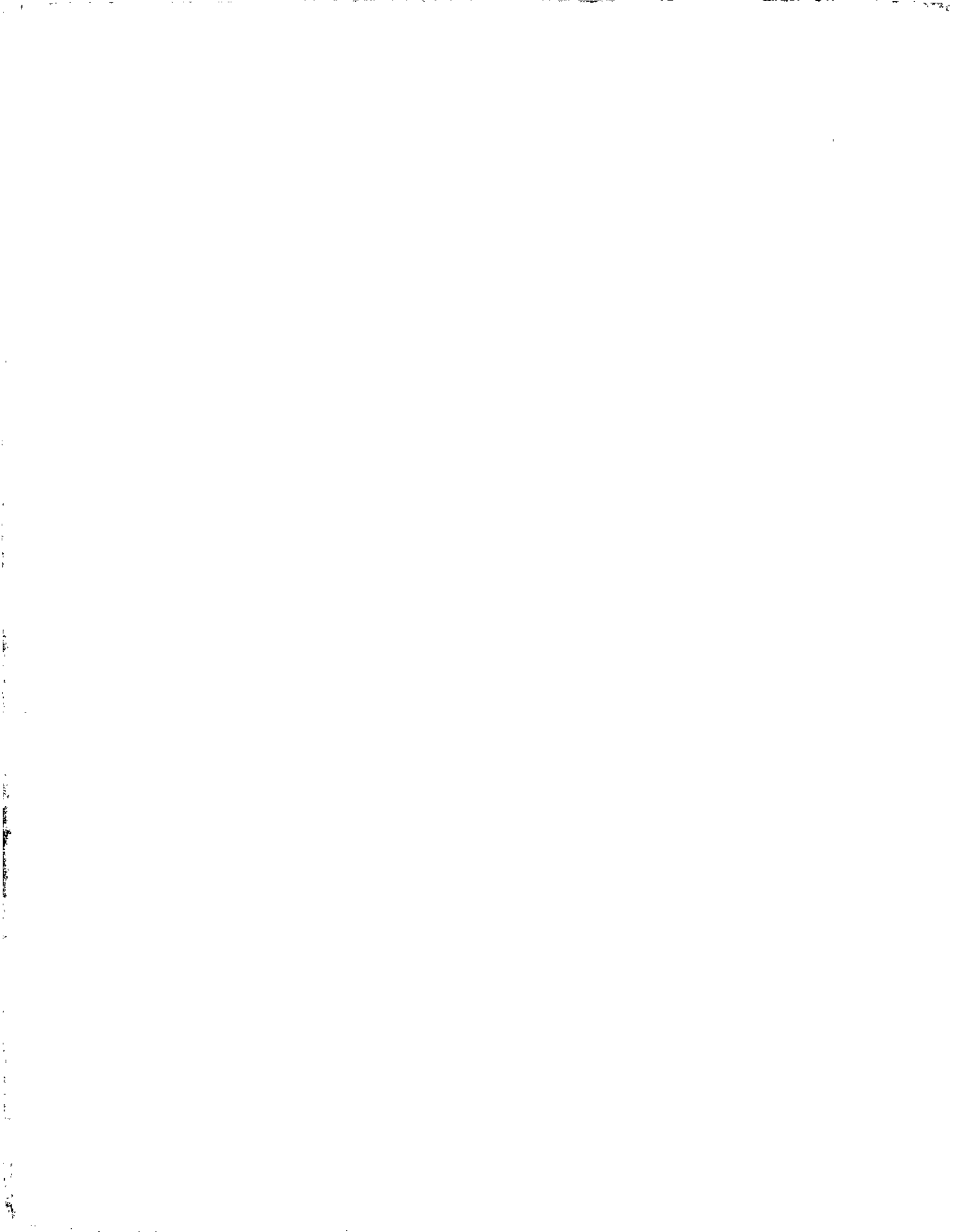
SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT4 Residential Two-Flat Townhouse and Multi-Unit District symbols and indications as shown on Map No. 13-I in the area bounded by

A line 40 feet north of and parallel to West Ainslie Street (as measured along the west boundary line of North Western Avenue); North Western Avenue; West Ainslie Street; North Lincoln Avenue,

to those of a B1-1 Neighborhood Shopping District.
