Section 1:

The ordinance passed by the City Council of the City of Chicago for **INTELLIGENTSIA COFFEE & TEA, INC.** on **06/12/2019**, and printed upon page **1549** of the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words "Said sidewalk cafe area #1 shall be fifteen point one seven (15.17) feet in length and seven point one seven (7.17) feet in width, area #2 shall be sixteen (16) feet in length and seven point one seven (7.17) feet in width for a total of two hundred twenty-three point four nine (223.49) square feet; Seating Capacity: 15; Sunday through Saturday 8:00 a.m. to 9:00 p.m." and inserting in their place the words "Said sidewalk cafe area #1 shall be nineteen point one seven (19.17) feet in length and seven (7) feet in width, said sidewalk café area #2 shall be nine point one seven (9.17) feet in length and seven (7) feet in width for a total of one hundred ninety-eight point three eight (198.38) square feet; Seating capacity: 23; Sunday through Saturday 8:00 a.m. to 8:00 p.m."
