BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached Housing) District, as shown on Map 3-G in the area bounded by:

West Walton Street, a line 221.00 feet East of North Ashland Avenue, the alley South and parallel to West Walton Street and a line 246.07 feet East of North Ashland Avenue.

To those of **RM-4.5** Residential Multi-Unit District

SECTION 2. This ordinance takes effect after its passage and approval.

NARRATIVE DESCRIPTION AND PLANS
FOR THE PROPOSED REZONING AT
1537 WEST WALTON STREET

The Application is to change zoning for 1537 West Walton from RS-3 to RM-4.5 Residential Multi-Unit District. The Applicant intends to construct a three (3) dwelling unit building with garage parking at 1537 West Walton Street. The footprint of the building shall be approximately 20 feet by 81 feet 2 inches in size. The building shall be 44 feet 11 inches as defined by City Zoning Code.


In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about July 13, 2016, the undersigned will file an application for a change in zoning from RS-3 Residential Single-Unit (Detached House) District to RM-4.5 Residential Multi-Unit District for the property located at 1537 West Walton Street, Chicago, Illinois.
