ORDINANCE DONALD MARTIN Acct. No. 293021 - 1 Permit No. 1108202

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to DONALD MARTIN, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, thirty-eight (38) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 1634-36 W. Montrose Ave..

Said Canopy(s) at W. MONTROSE AVE. measure(s):

Four (4) at nine point nine (9.9) feet in length, and two (2) feet in width for a total of seventy-nine point two (79.2) square feet.

Said Canopy(s) at W. MONTROSE AVE. measure(s):

Two (2) at seven (7) feet in length, and two (2) feet in width for a total of twenty-eight (28) square feet.

Said Canopy(s) at N. PAULINA measure(s):

Thirteen (13) at nine point nine (9.9) feet in length, and two (2) feet in width for a total of two hundred fifty-seven point four (257.4) square feet.

Said Canopy(s) at N. PAULINA measure(s):

Fifteen (15) at three point nine (3.9) feet in length, and two (2) feet in width for a total of one hundred seventeen (117) square feet.

Said Canopy(s) at N. PAULINA measure(s):

Four (4) at four (4) feet in length, and two (2) feet in width for a total of thirty-two (32) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1108202 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 07/27/2013.
