North Elston Avenue; a line 56.26 feet northwest of and parallel to West Barry Avenue; the public alley next southwest of and parallel to North Elston Avenue and a line 81.26 feet northwest of West Barry Avenue,

to those of a B2-2 Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
