**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:**

**WARD           LOADING ZONES / STANDING ZONES:**

- 27           West Hubbard Street (north side) from a point 30 feet west of North Aberdeen Street to a point 75 feet west thereof; No Parking Loading Zone, 10:00am to 2:00am, All Days [O2018-5974]
- 37           5515 West North Avenue (south side) from a point 50 feet west of North Linder Avenue to a point 20 feet west thereof; 30 Minute Standing Zone, Use Flashing Lights, 7:00am to 7:00pm, Monday through Saturday -- (18-00531318) [O2018-194]
- 41           North Northwest Highway (north side) of North Oliphant Avenue to a point 25 feet west thereof; 15 Minute Standing Zone, Use Flashing Lights, All Times, All Days, Public Benefit [O2018-5910]
- 44           North Clark Street (east side) from a point 335 feet north of West Wellington Avenue to a point 20 feet north thereof; 15 Minute Standing Zone, Use Flashing Lights, 8:00am to 8:00pm, Monday through Saturday -- (18-01310794) [O2018-3991]
- 44           West Grace Street (north side) from a point 25 feet east of North Racine Avenue to a point 20 feet east thereof; 15 Minute Standing Zone, Use Flashing Lights, 11:00am to 11:00pm, All Days -- (18-01888985) [O2018-4925]
