ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current B3-5 Community Shopping District and the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 5-H in the area bounded by:

a line 212.50 feet southeast of West Wabansia Avenue as measured along the northeasterly line of North Milwaukee Avenue; the public alley next northeast of and parallel to North Milwaukee Avenue; a line 308.50 feet southeast of West Wabansia Avenue as measured along the northeasterly line of North Milwaukee Avenue; and North Milwaukee Avenue

to those of a B3-3 Community Shopping District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

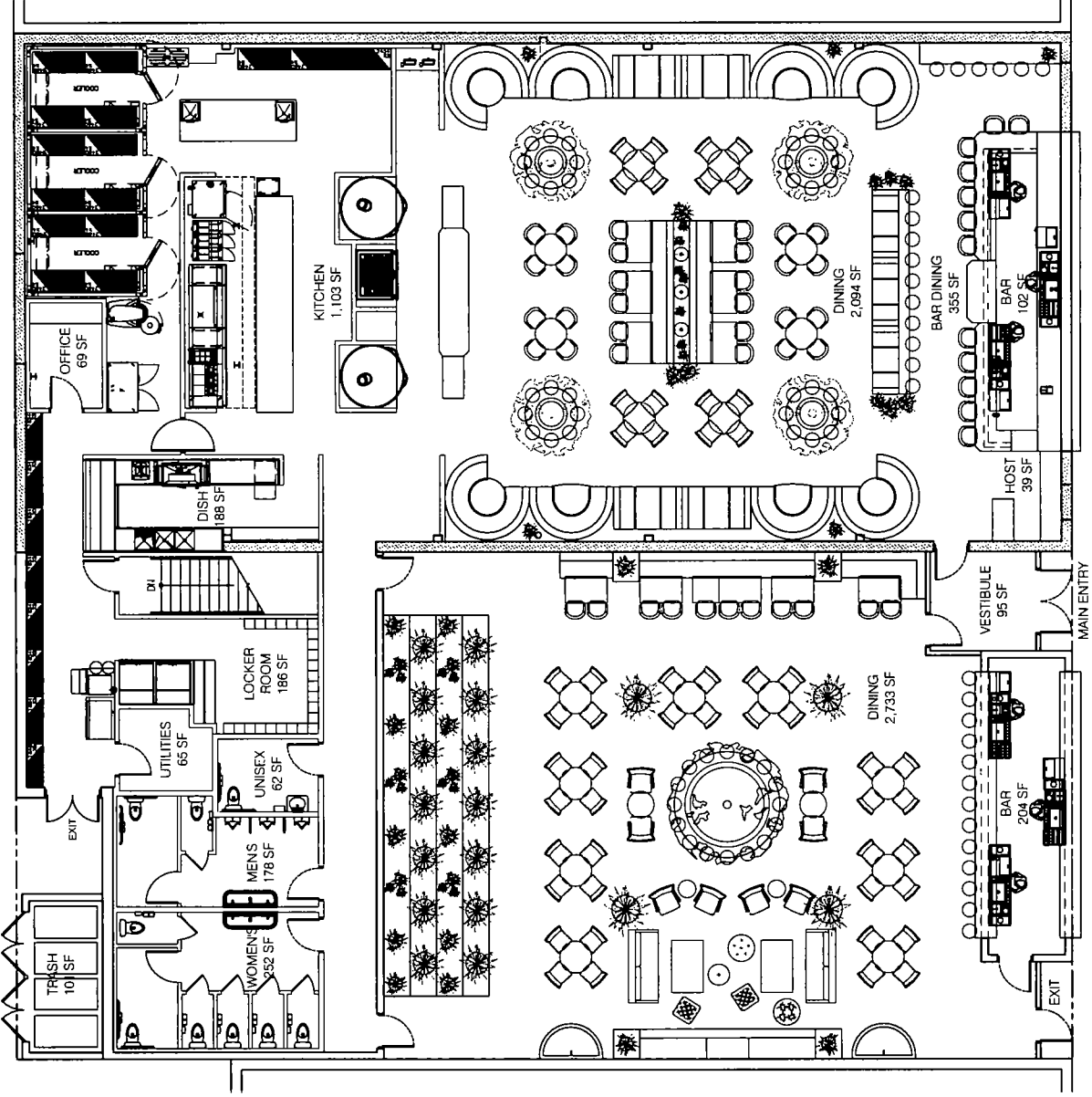
Narrative: The subject property consists of a one-story vacant commercial building and a vacant lot that measures 4,829 square feet. The Applicant proposes to rezone the property from a B3-5 Community Shopping District and a M1-2 Limited Manufacturing/Business Park District to a B3-3 Community Shopping District to redevelop the property into a one-story restaurant with an addition that has a seasonal retractable roof for a total of 9,402 square feet. There will be no residential use. The proposed height will be 23.00 feet. No automobile parking*, bicycle parking*, or loading** currently exists, is required, or will be provided.

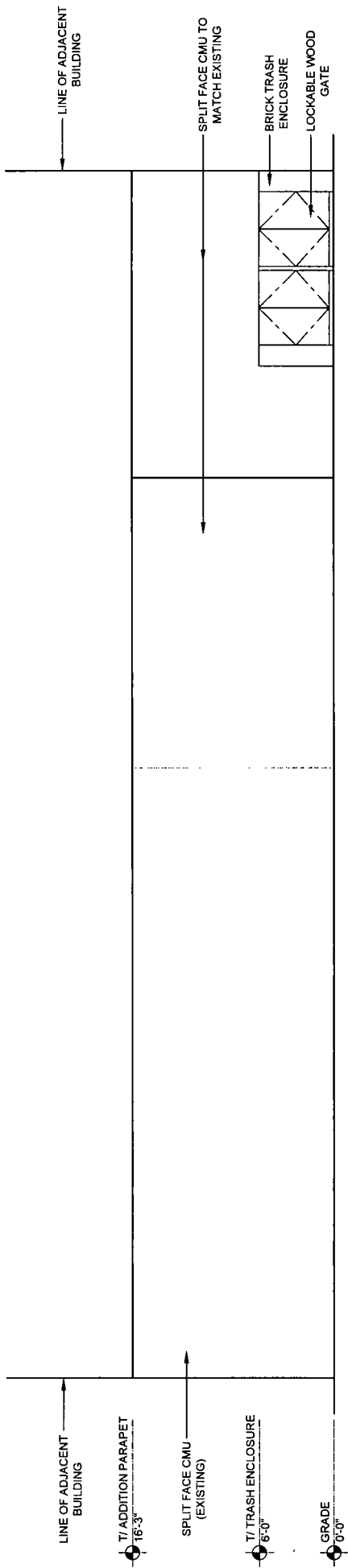

REAR ELEVATION (SOUTH)

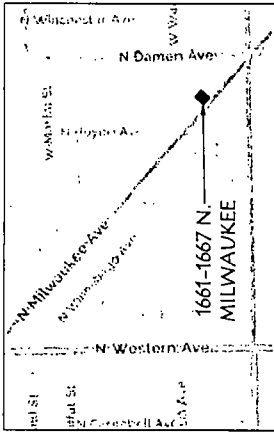

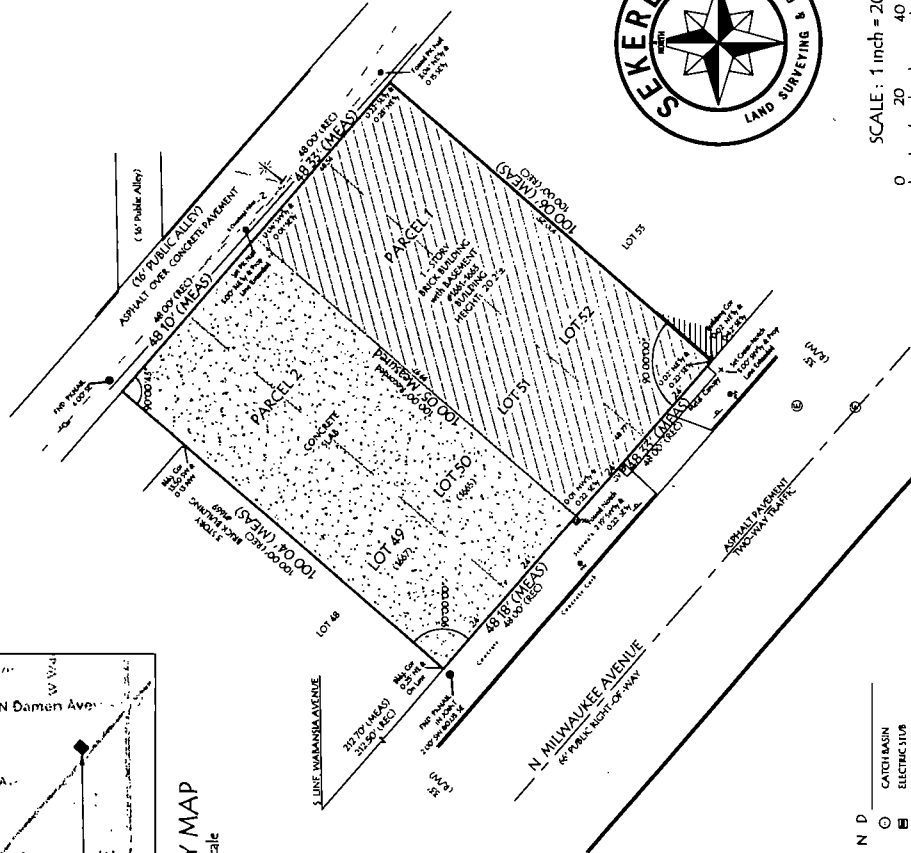

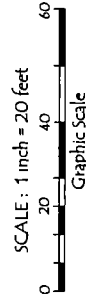


VICINITY MAP
