WEST TAYLOR STREET; SOUTH CANAL STREET; VACATED WEST GRENSHAW STREET; AND SOUTH CLINTON STREET.

to those of a DX-5, Downtown Mixed-Use District symbols and a corresponding use district is hereby established.

SECTION 2. That the Chicago Zoning Ordinance be amended by changing all the DX-5 symbols and indications in the area described above to those of Business-Residential Planned Development No. , and a corresponding use district is hereby established.

SECTION 3. This ordinance shall be in force and effect from and after its passage and due publication.

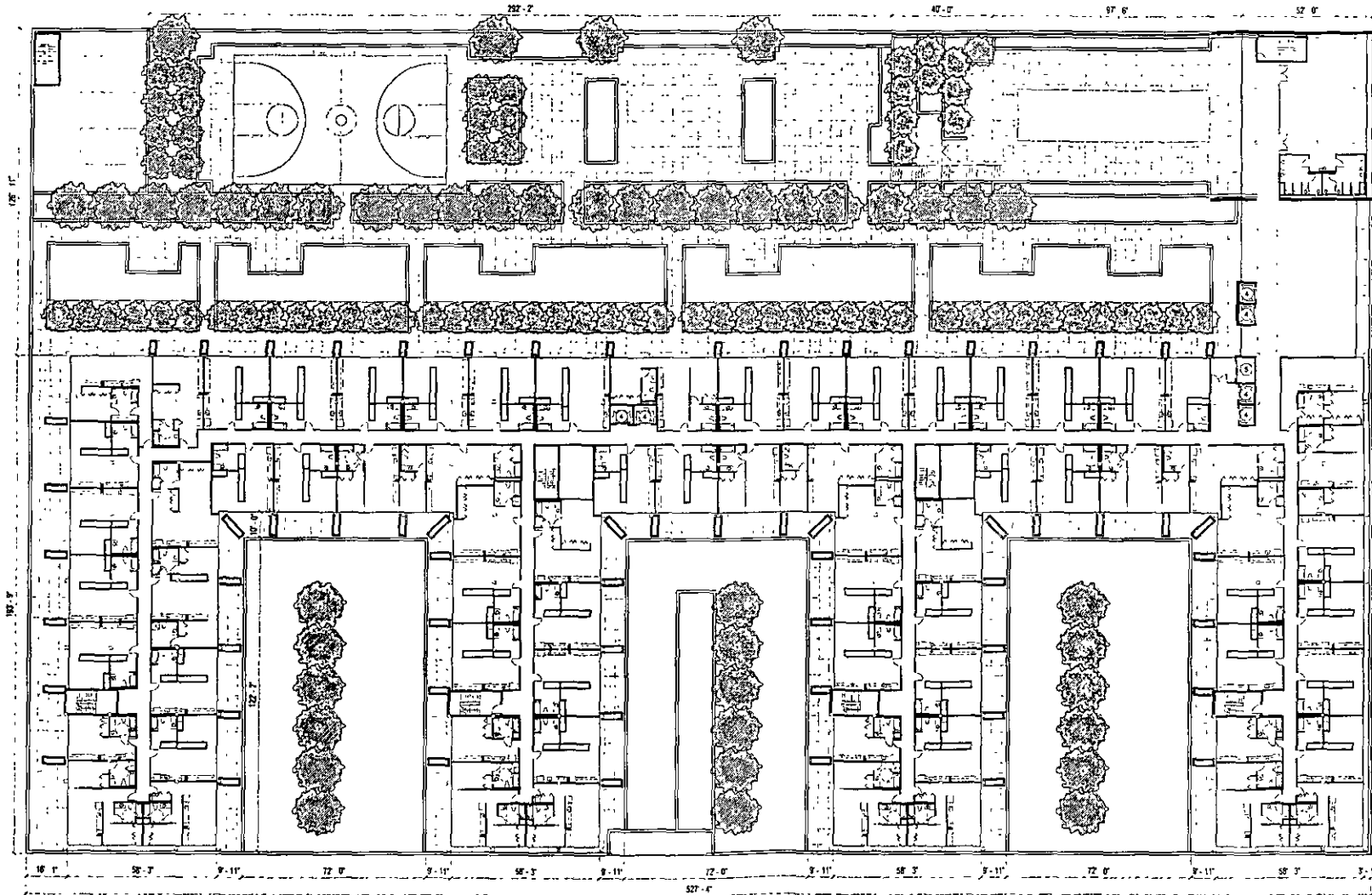


NORTH ELEVATION
