**APPLICATION FOR ZONING MAP AMENDMENT**

**TYPE 1 ZONING ANALYSIS**

The applicants are seeking to rezone the subject property from its existing RM-6 classification to a B1-1 classification to permit the property to be used as co-working space where business professionals share office space and resources. Following is the additional information regarding the proposed development required for the subject application:
