Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CANDYALITY LTD., upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, ten (10) Awning(s) projecting over the public right-of-way adjacent to its premises known as 3425 N. Southport Ave..

Said Awning(s) at N. Southport Avenue measure(s):

One (1) at ten point one seven (10.17) feet in length, and two point three three (2.33) feet in width for a total of twenty-three point seven (23.7) square feet.

One (1) at six point five (6.5) feet in length, and two point three three (2.33) feet in width for a total of fifteen point one five (15.15) square feet.

One (1) at four point six seven (4.67) feet in length, and two point three three (2.33) feet in width for a total of ten point eight eight (10.88) square feet.

Said Awning(s) at W. Newport measure(s):

One (1) at four point seven five (4.75) feet in length, and two point three three (2.33) feet in width for a total of eleven point zero seven (11.07) square feet.

Four (4) at four point three three (4.33) feet in length, and two point three three (2.33) feet in width for a total of forty point three six (40.36) square feet.

Two (2) at six point five (6.5) feet in length, and two point three three (2.33) feet in width for a total of thirty point two nine (30.29) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1106274 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

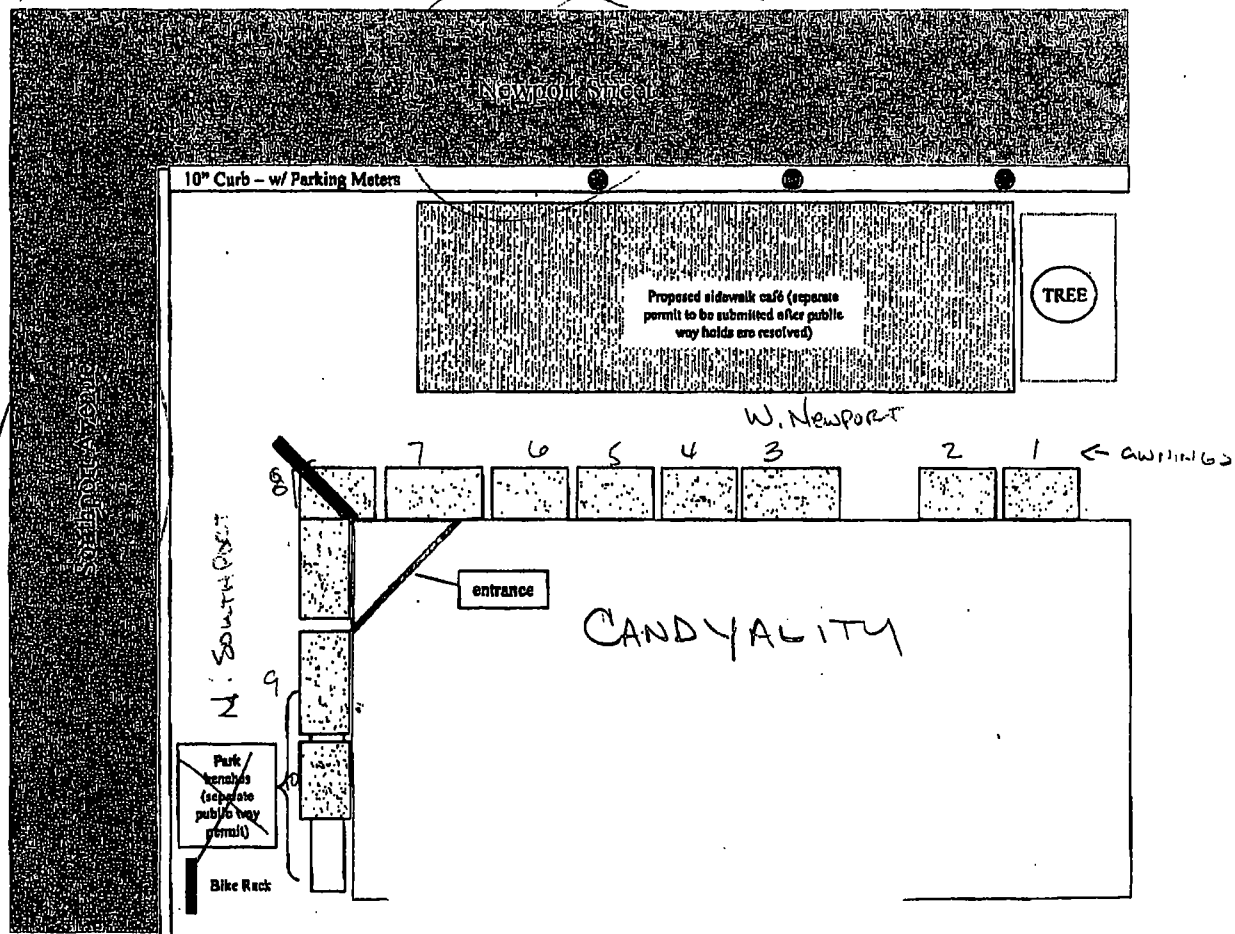
