**West Le Moyne Street; North Maplewood Avenue; a line 48 feet South of and parallel to West Le Moyne Street; the public alley next West of and parallel to North Maplewood Avenue.**

**To those of an RM5, Residential Multi-Unit District**

**SECTION 2. This Ordinance takes effect after its passage and approval.**

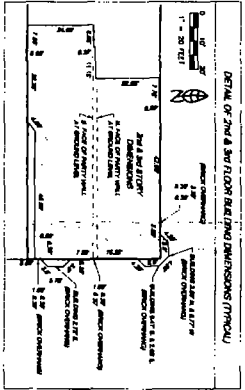
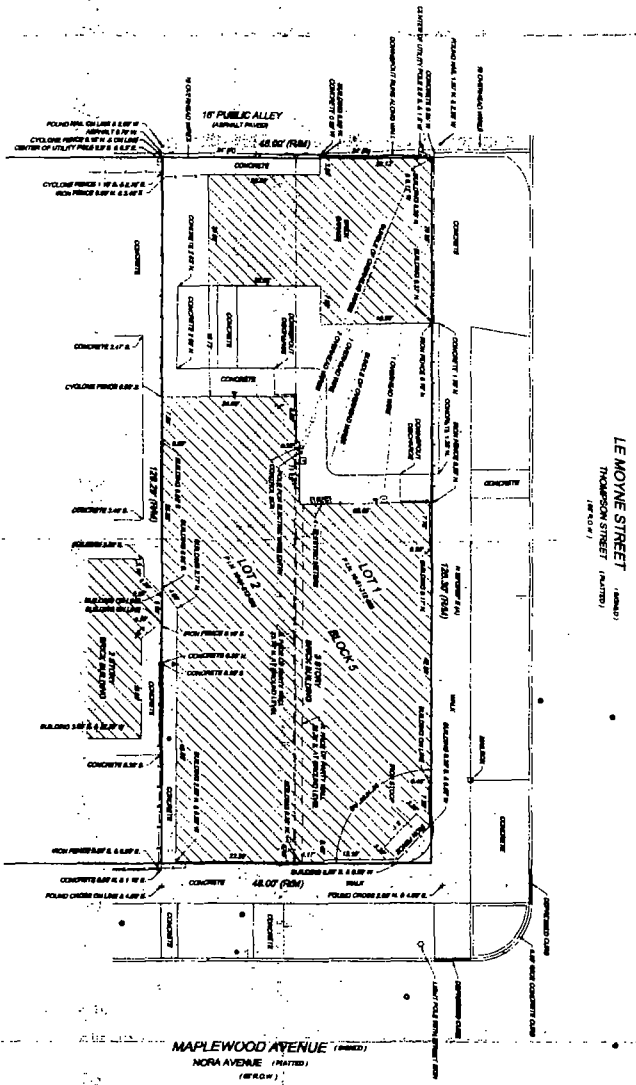
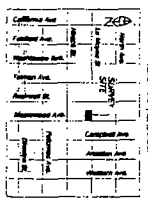
