**North Monticello Avenue, a line 597.65 feet North of West Wabansia, North Central Park Avenue and a line 541 feet North of West Wabansia Avenue.**

**To those of RT-4 Residential Two-Flat, Townhouse and Multi-Unit District.**

**SECTION 2.** This ordinance takes effect after its passage and approval.

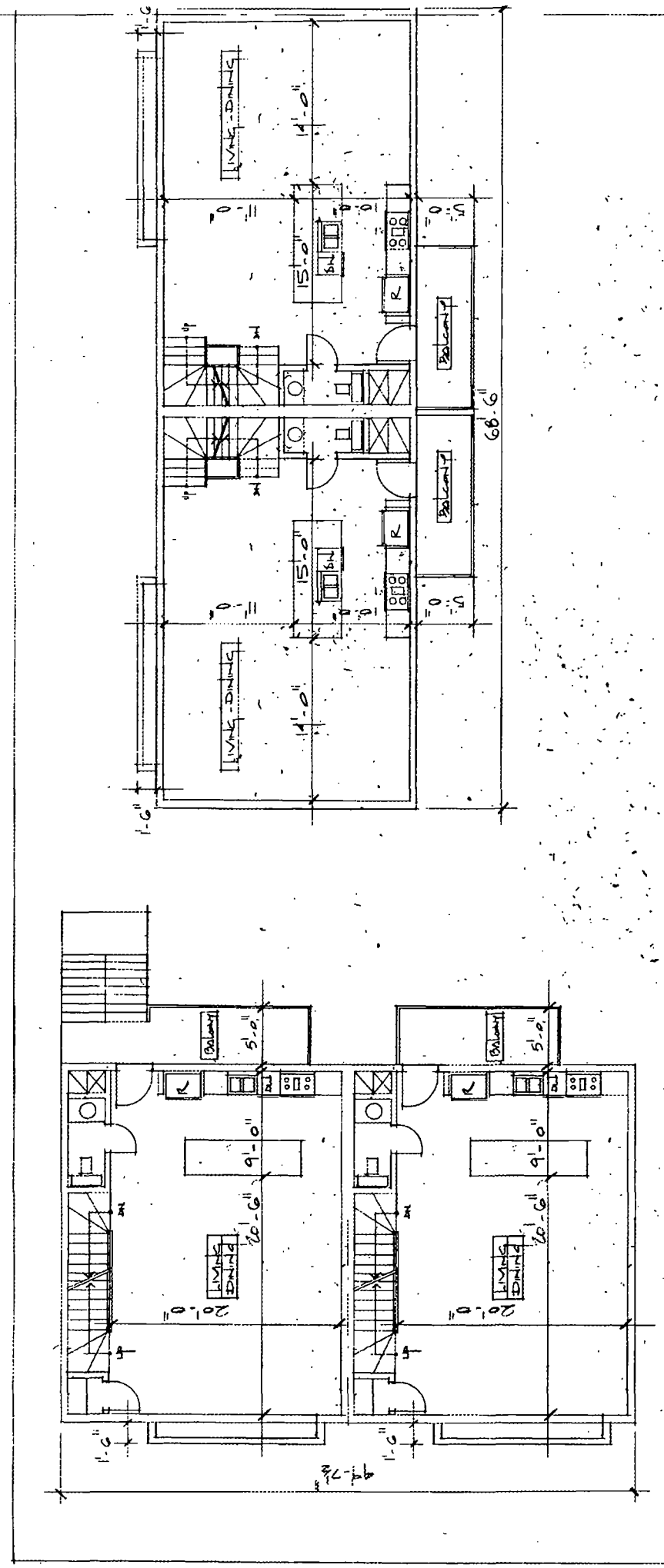


1st Floor Plan

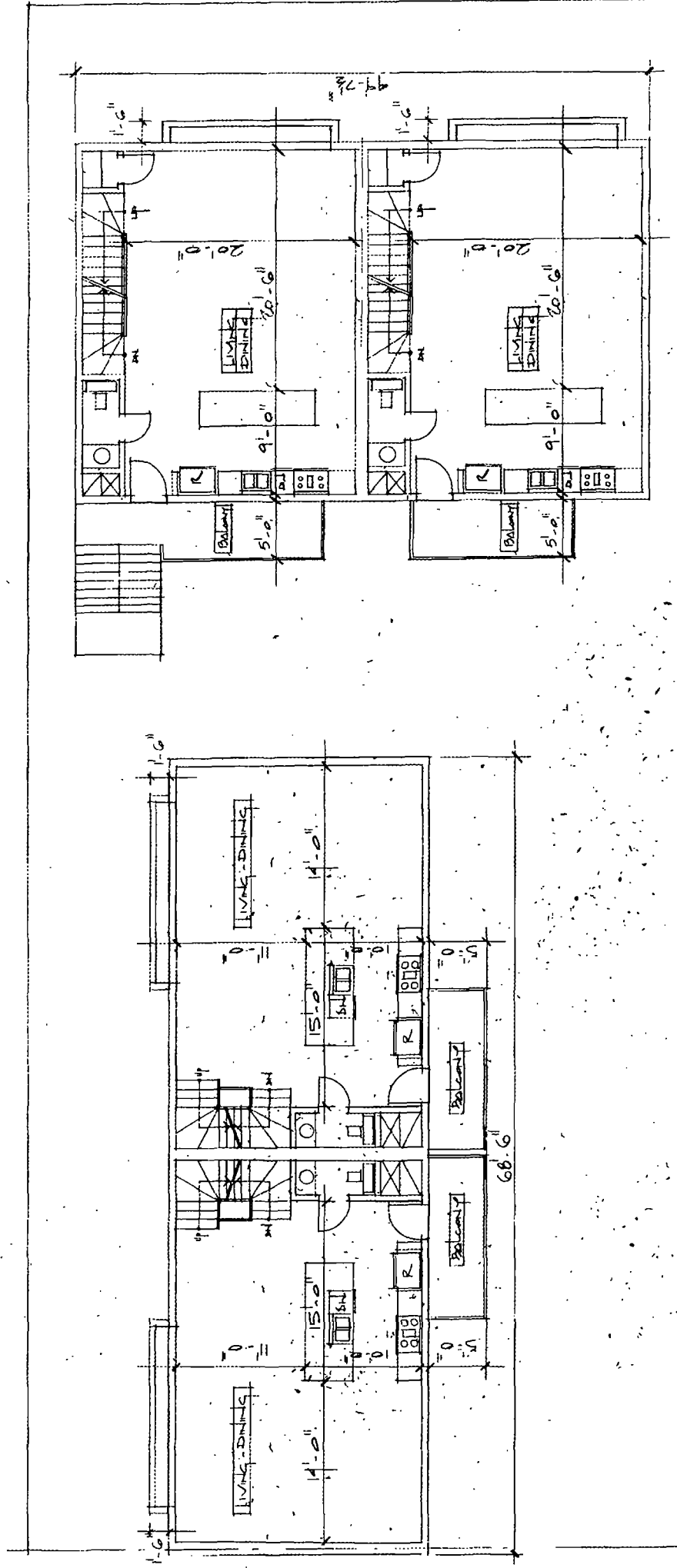




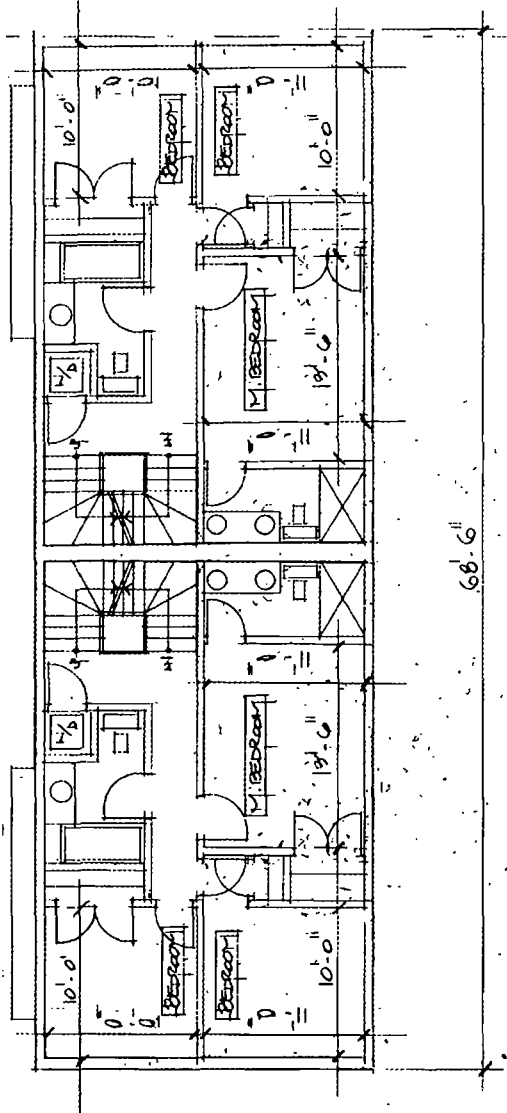
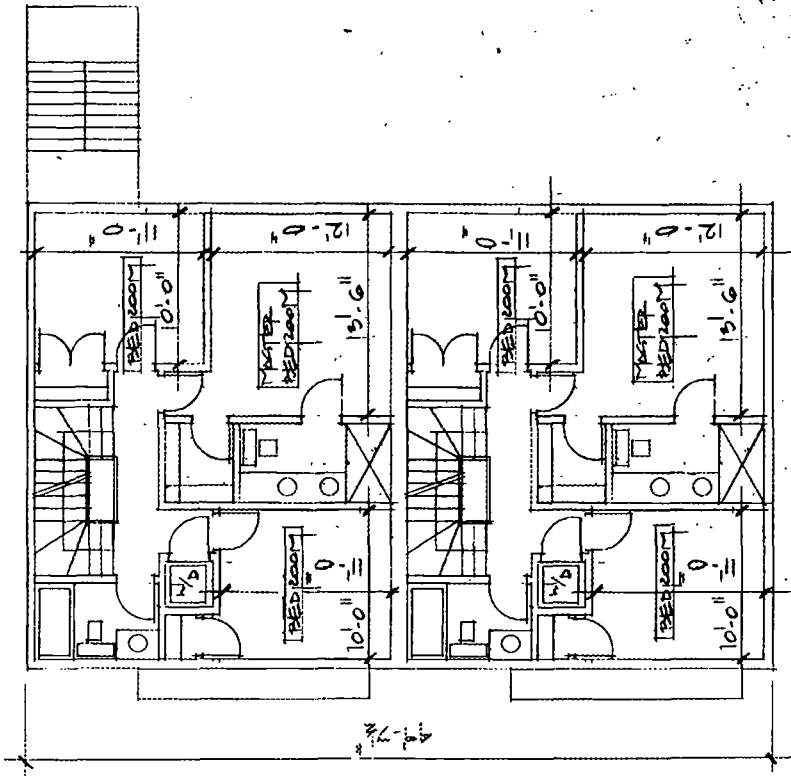
1<sup>ST</sup> FLOOR PLAN

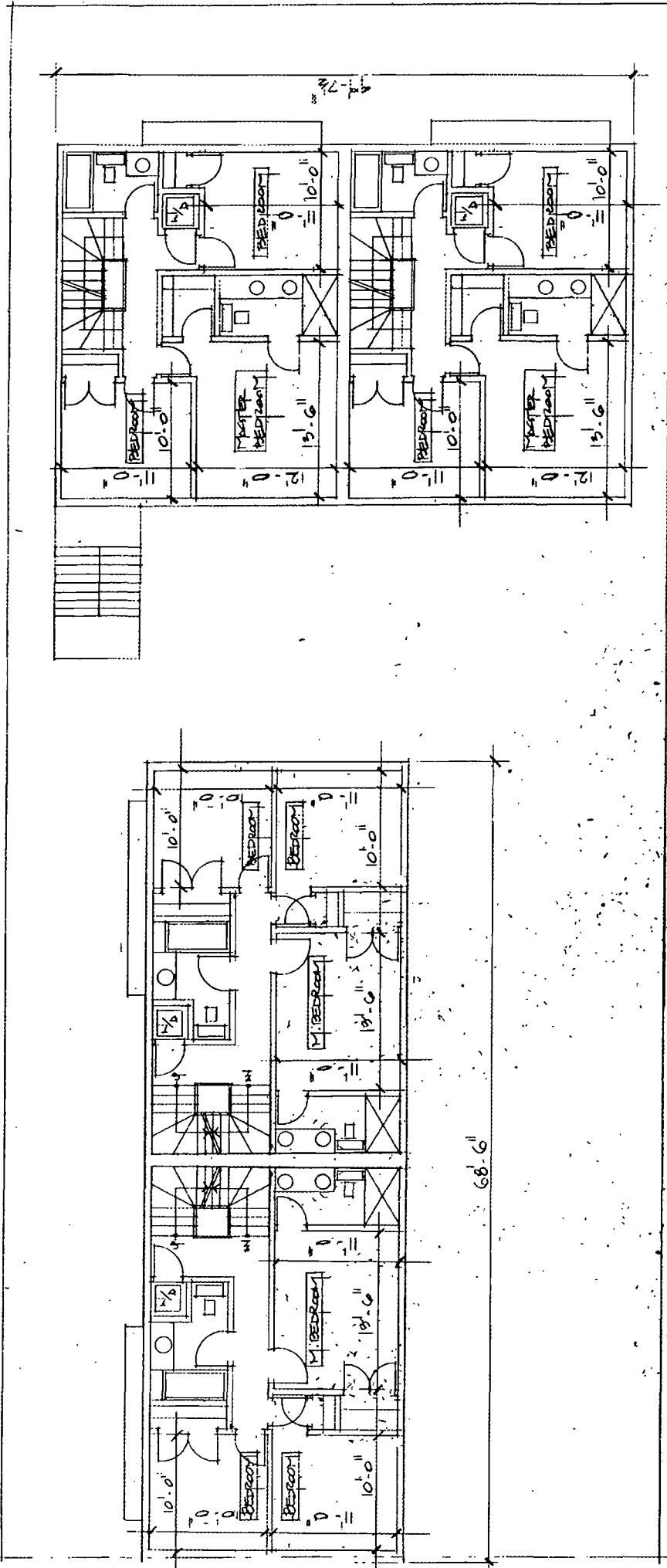


2nd Floor Plan

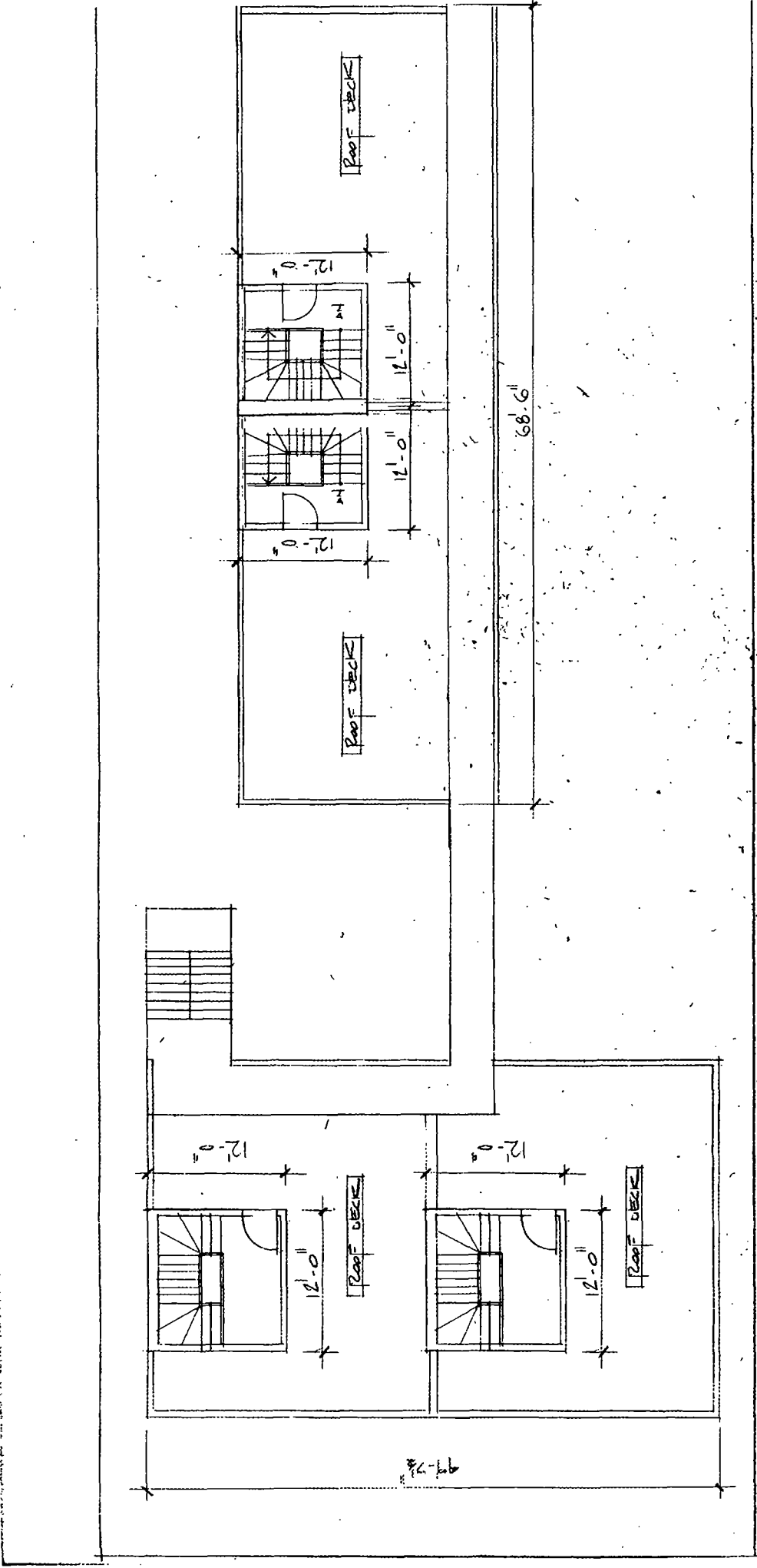
1st Floor Plan

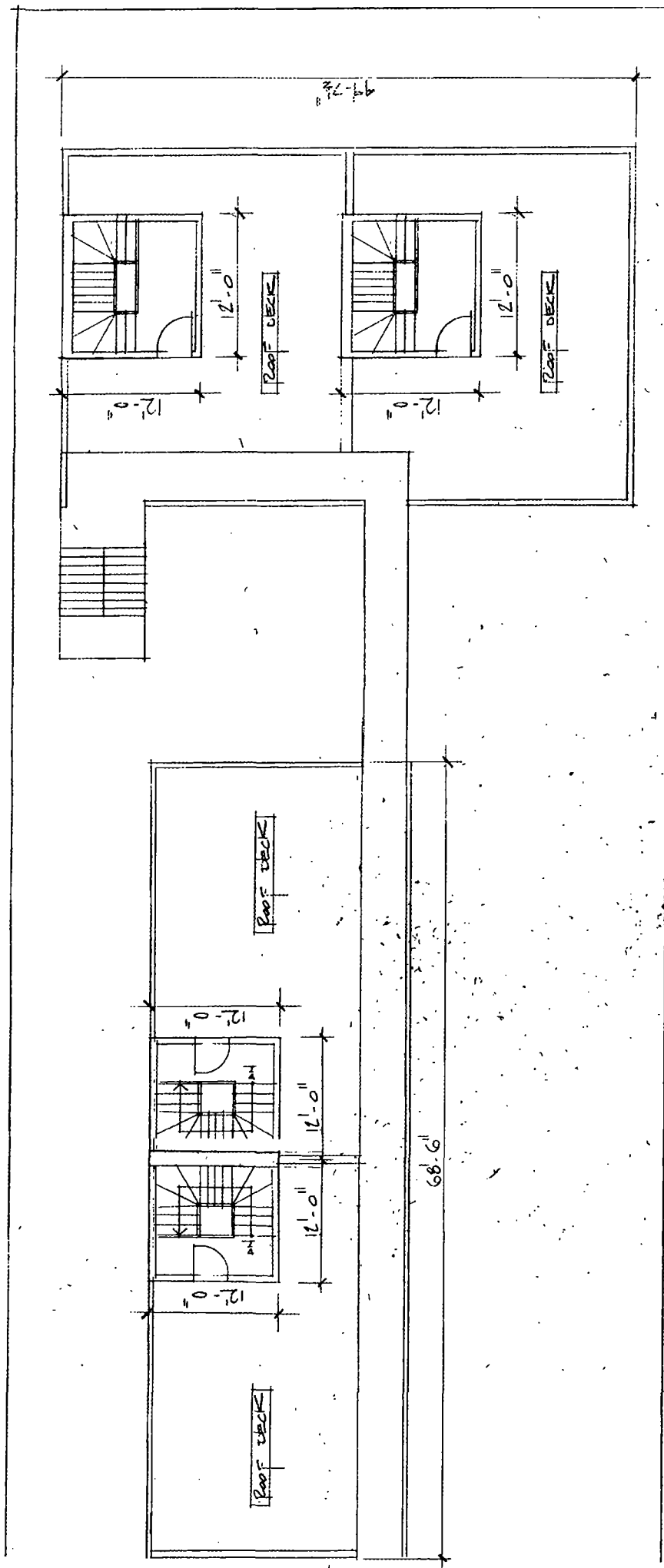


3rd Floor Plan

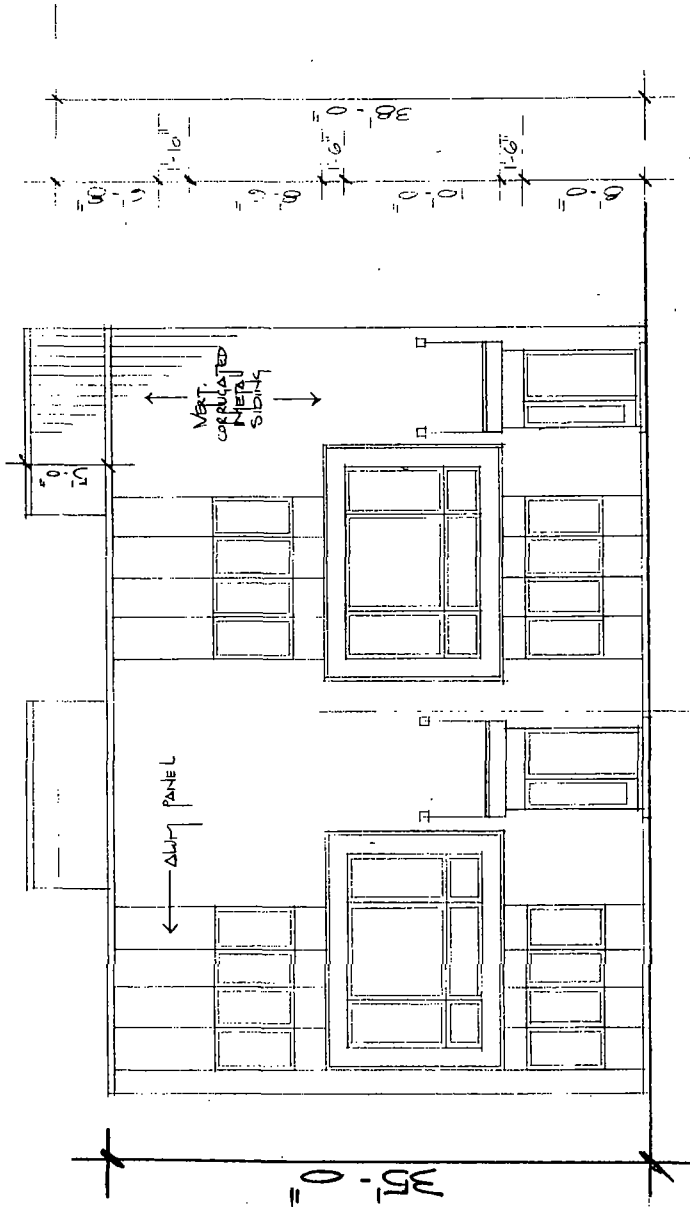

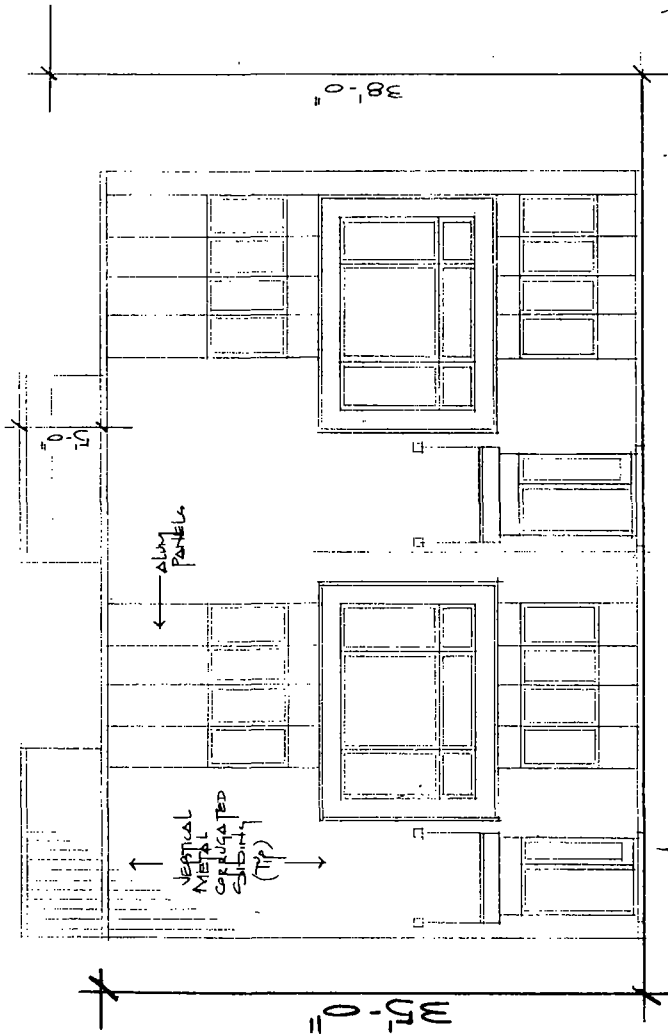
CENTRAL PARK AVE. ELEVATION

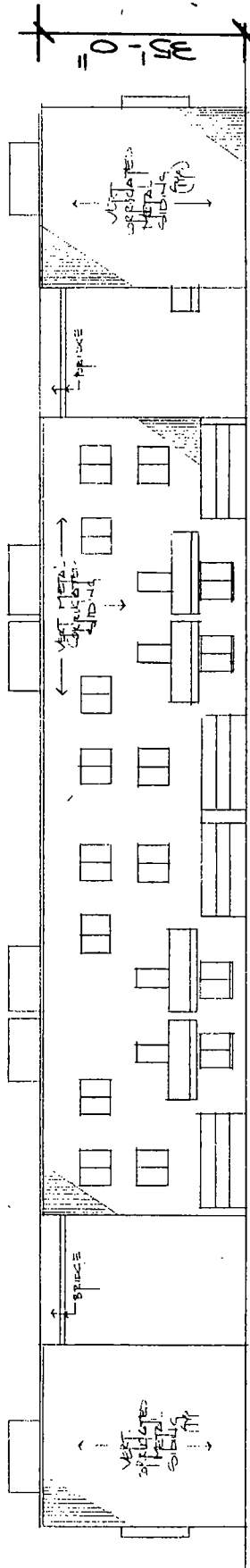
MONTICELLO AVE ELEVATION

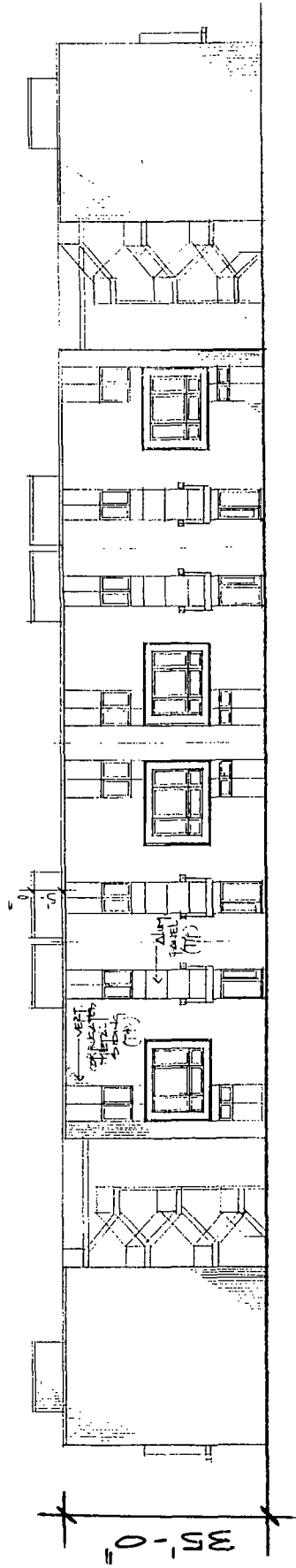

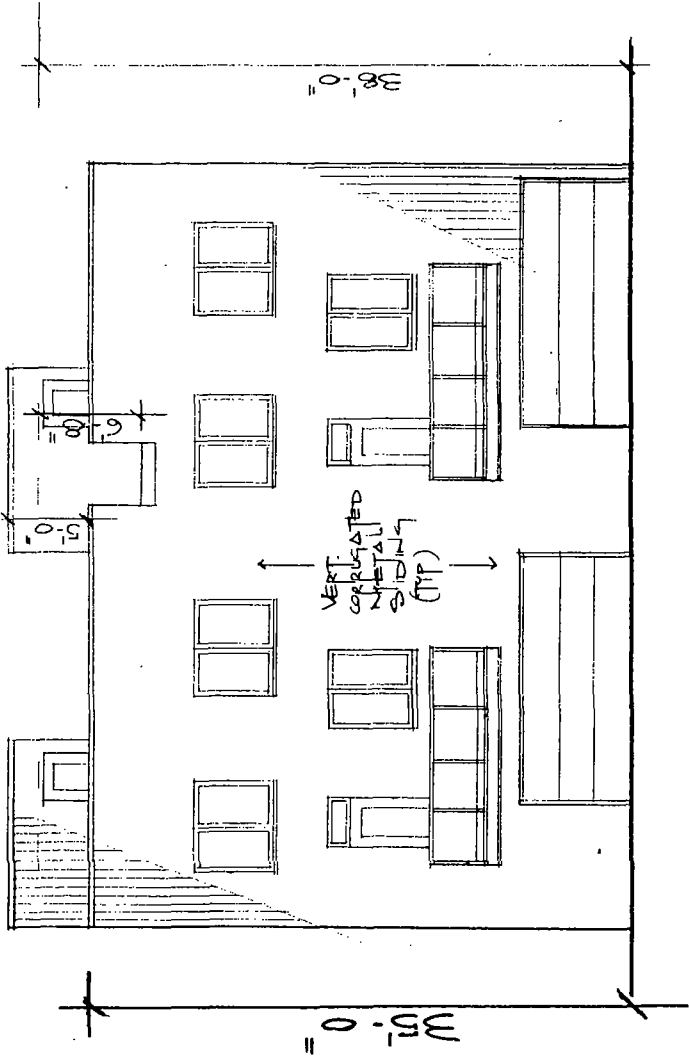

CENTRAL PARK AVE - REAR ELEVATION

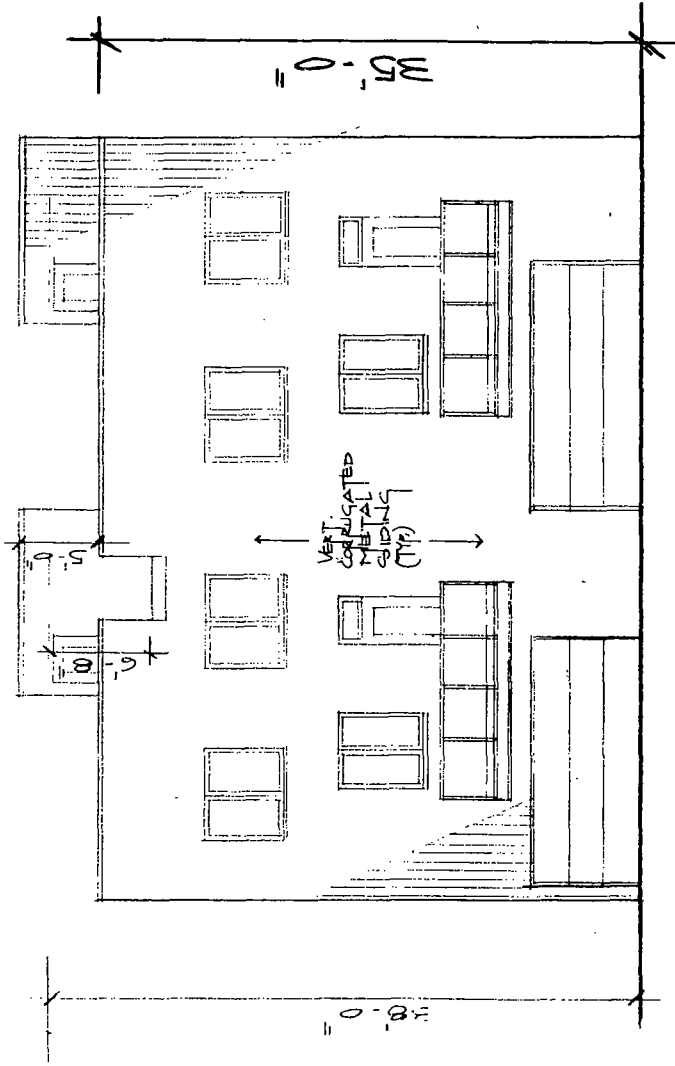

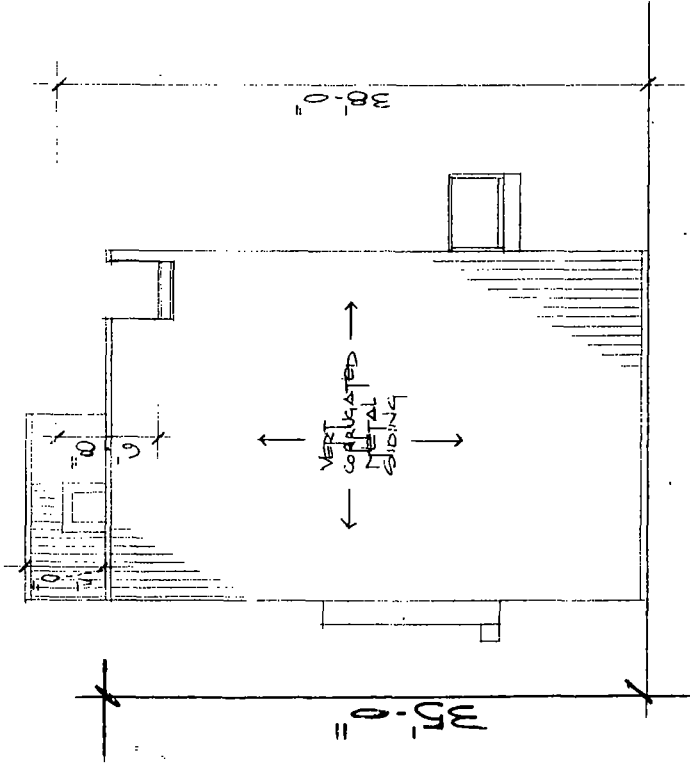
MONTICELLO AVE. - REAR ELEVATION

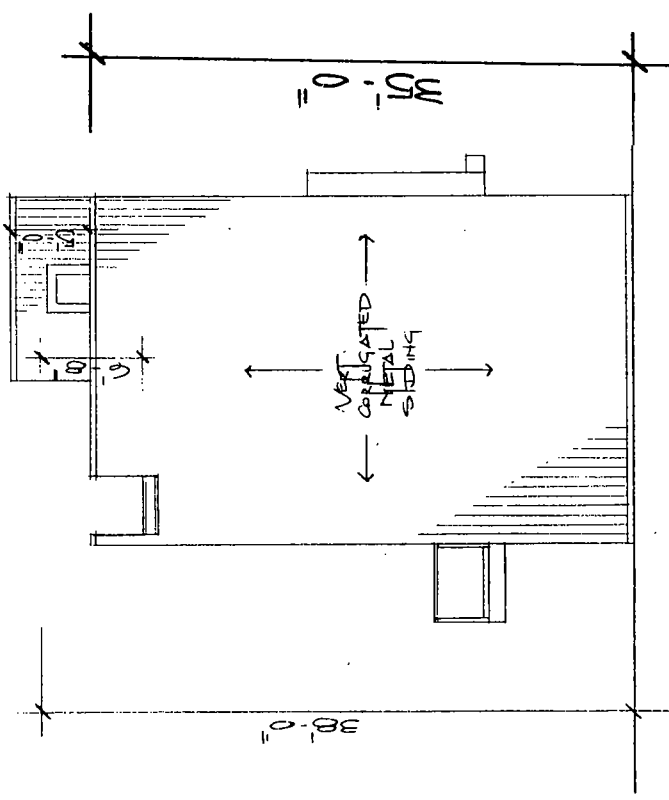
WEST ELEVATION (SIDE OF 4 TOWNHOMES)
