ORDINANCE

WHEREAS, On November 14, 2018 the City Council of the City of Chicago adopted the Year XLV Community Development Block Grant Ordinance (the "Year XLV CDBG Ordinance"); and

WHEREAS, The City, through its Department of Housing ("DOH"), desires to authorize the name change of a delegate agency funded under the Homeownership Counseling Services Program, now, therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. The above recitals are expressly incorporated into and made a part of this ordinance.

SECTION 2. The Year XLV CDBG Ordinance, as amended, is hereby further amended by deleting the struck-through text and adding the underscored text indicated in Exhibit A attached hereto.

SECTION 3. This ordinance shall be in full force and effect upon its passage and approval.
