ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois; and

WHEREAS, the City has certain funds available from a variety of funding sources ("Multi-Family Program Funds") to make loans and grants for the development of multi-family residential housing to increase the number of families served with decent, safe, sanitary and affordable housing and to expand the long-term supply of affordable housing, and such Multi-Family Program Funds are administered by the City's Department of Housing and Economic Development ("HED"); and

WHEREAS, HED has preliminarily reviewed and approved the making of a loan of Multi-Family Program Funds (the "Loan") to either The Burton Foundation, an Illinois not-for-profit corporation (or an entity affiliated therewith) (collectively, "Burton"), or to Rosenwald Courts Apartments, LP, an Illinois limited partnership (or an entity affiliated therewith) (collectively, "Rosenwald") (Burton or Rosenwald, as applicable, the "Borrower"), to finance the acquisition of a building and land located at 4600 South Michigan Avenue, Chicago, Illinois (the "Property"); and

WHEREAS, HED is seeking authorization to make the Loan to the Borrower with the following terms: (1) the amount of the Loan shall not exceed \$5,000,000, (2) the term of the Loan shall not exceed 44 years, (3) the interest rate on the Loan shall be zero percent per annum, and (4) security for the Loan shall consist of a first mortgage on and deed to the Property in favor of the City, or such other security as may be acceptable to the hereinafter defined Authorized Officer (collectively, the "Loan Terms"); now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Commissioner of HED (the "Commissioner") and a designee of the Commissioner (collectively, the "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter into, execute and accept such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with the implementation of the Loan, including but not limited to the exercise of the City's rights with respect to the security therefor. The Authorized Officer is hereby authorized, subject to the approval of the Corporation Counsel, to negotiate any and all terms and provisions in connection with the Loan which do not substantially modify the Loan Terms described herein. Upon the execution and receipt of proper documentation, the Authorized Officer is hereby authorized to disburse the proceeds of the Loan to the Borrower.

SECTION 3. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance. Section 2-45-110 of the Municipal Code of Chicago shall not apply to the Property and the acquisition thereof by the Borrower in connection with the Loan.

SECTION 4. This ordinance shall be effective as of the date of its passage and approval.



B.
