ORDINANCE SHEFFIELD PROPERTIES OF ILLINOIS INC Acct. No. 380838 - 1 Permit No. 1106382

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SHEFFIELD PROPERTIES OF ILLINOIS INC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Slurry Wall(s) under the public right-of-way adjacent to its premises known as 930-980 N. Michigan Ave..

Said Slurry Wall(s) at East Oak Street measure(s):

One (1) at two hundred eighteen point nine two (218.92) feet in length, and two (2) feet in width for a total of four hundred thirty-seven point eight four (437.84) square feet. Existing slurry wall is approximately four (4) feet below grade level.in depth.

Said Slurry Wall(s) at North Michigan Avenue measure(s):

One (1) at two hundred forty point eight three (240.83) feet in length, and two (2) feet in width for a total of four hundred eighty-one point six six (481.66) square feet. Existing slurry wall is approximately four (4) feet below grade level.

Said Slurry Wall(s) at East Walton Street measure(s):

One (1) at one hundred eighteen point two five (118.25) feet in length, and two (2) feet in width for a total of two hundred thirty-six point five (236.5) square feet. Existing slurry wall is approximately four (4) feet below grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1106382 herein granted the sum of nine thousand two hundred sixty-two (\$9,262.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
