BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1:

The ordinance passed by the City Council of the City of Chicago for **URBAN POOCH CANINE LIFE CENTER** is here by Amended by deleting the words:

"to maintain and use four (4) awnings

Said awnings at N. Ravenswood measure(s): One (1) at nine point eight (9.8) feet in length and four (4) feet in width for a total of thirty-nine point two (39.2) square feet.
