### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1:** That the Chicago Zoning Ordinance be amended by changing all of the C1-2, Neighborhood Commercial District and symbols and indications as shown on Map Number 3-F in the area bounded by:

North Orleans Street; West Walton Street; the public alley next east of and parallel to North Orleans Street; and West Locust Street,

to those of C1-5, Neighborhood Commercial District.

**SECTION 2:** That the Chicago Zoning Ordinance be amended by changing all of the RT-4, Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map Number 3-F in the area bounded by:

North Orleans Street; West Walton Street; a line approximately 155.20 feet west of and parallel to North Orleans Street; and West Locust Street,

to those of C1-5, Neighborhood Commercial District.

**SECTION 3:** That the Chicago Zoning Ordinance be amended by changing all of the C1-5, Neighborhood Commercial District symbols and indications as shown on Map Number 3-F in the area bounded by:

West Walton Street; the public alley next east of and parallel to North Orleans Street; West Locust Street; and a line approximately 155.20 feet west of and parallel to North Orleans Street,

to those of Planned Development [ ], which is hereby established in the area above described, subject to such use and bulk regulation as set forth in the Plan of Development herewith attached and made a part hereof and to no others.

**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage and due publication.







## NOTICE OF FILING OF REZONING APPLICATION

May 27, 2014

Dear Sir or Madam:

In accordance with the requirements of Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on May 27, 2014, Ascend Real Estate Group, LLC (the "Applicant") will file an application for rezoning (the "Application"). The Applicant proposes to construct a residential apartment building with retail on the ground floor on the property commonly known as 341 – 355 W. Walton Street, 325 – 333 W. Walton Street, 900 – 920 N. Orleans Street, 901 – 921 N. Orleans Street, 324 – 332 W. Locust Street, and 340 – 354 W. Locust Street (the "Property").

The proposed rezoning application will request City of Chicago approval to rezone the Property from RT-4, Residential Two-Flat, Townhouse and Multi-Unit District, and C1-2, Neighborhood Commercial District to C1-5, Neighborhood Commercial District and then to a Planned Development for the purpose of constructing a residential apartment building with 227 dwelling units, 152 parking spaces and approximately 3,300 square feet of commercial retail space on the Property (the "Project").



# Planned Development No. Existing Land Use Area Map




