## ORDINANCE

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-2 Limited manufacturing/Business Park District symbols and indications as shown on Map No.6-F in the area bounded by

the alley next southeast of and parallel to South Archer Avenue;  
a line from a point 155.41 feet northeast of South Emerald Avenue  
and the south right-of-way line of the alley next south of and parallel  
to South Archer Avenue; to a point, 192.34 feet northeast of South  
Emerald Avenue and the north right-of-way line of West 25<sup>th</sup> Street  
(Buena Vista Place); West 25<sup>th</sup> Street (Buena Vista Place); and South  
Emerald Avenue,

to those of a B2-1 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.

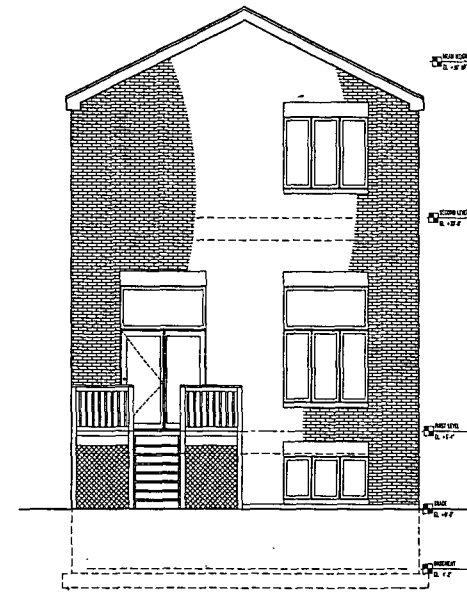
TYP. RIGHT ELEVATION

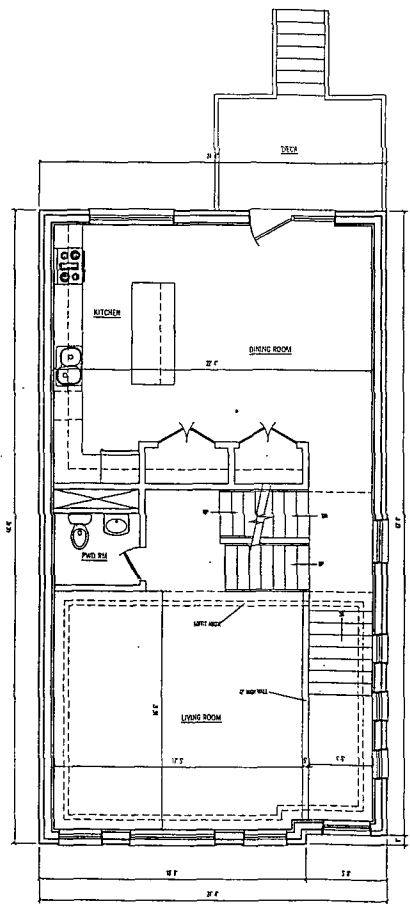

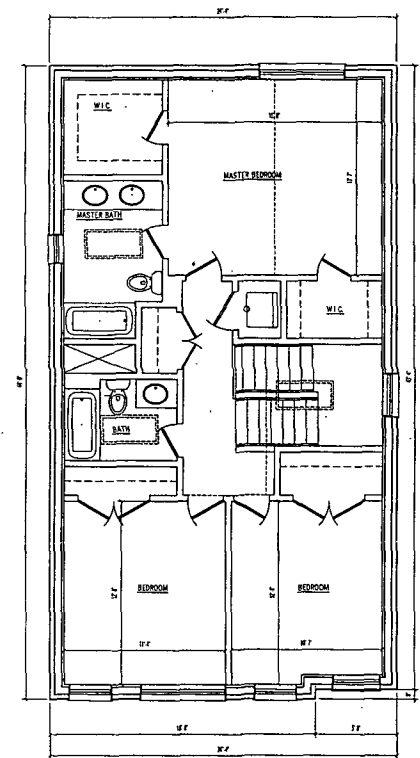
BASEMENT PLAN

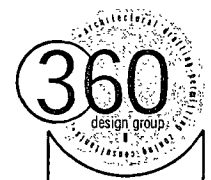
FIRST FLOOR PLAN

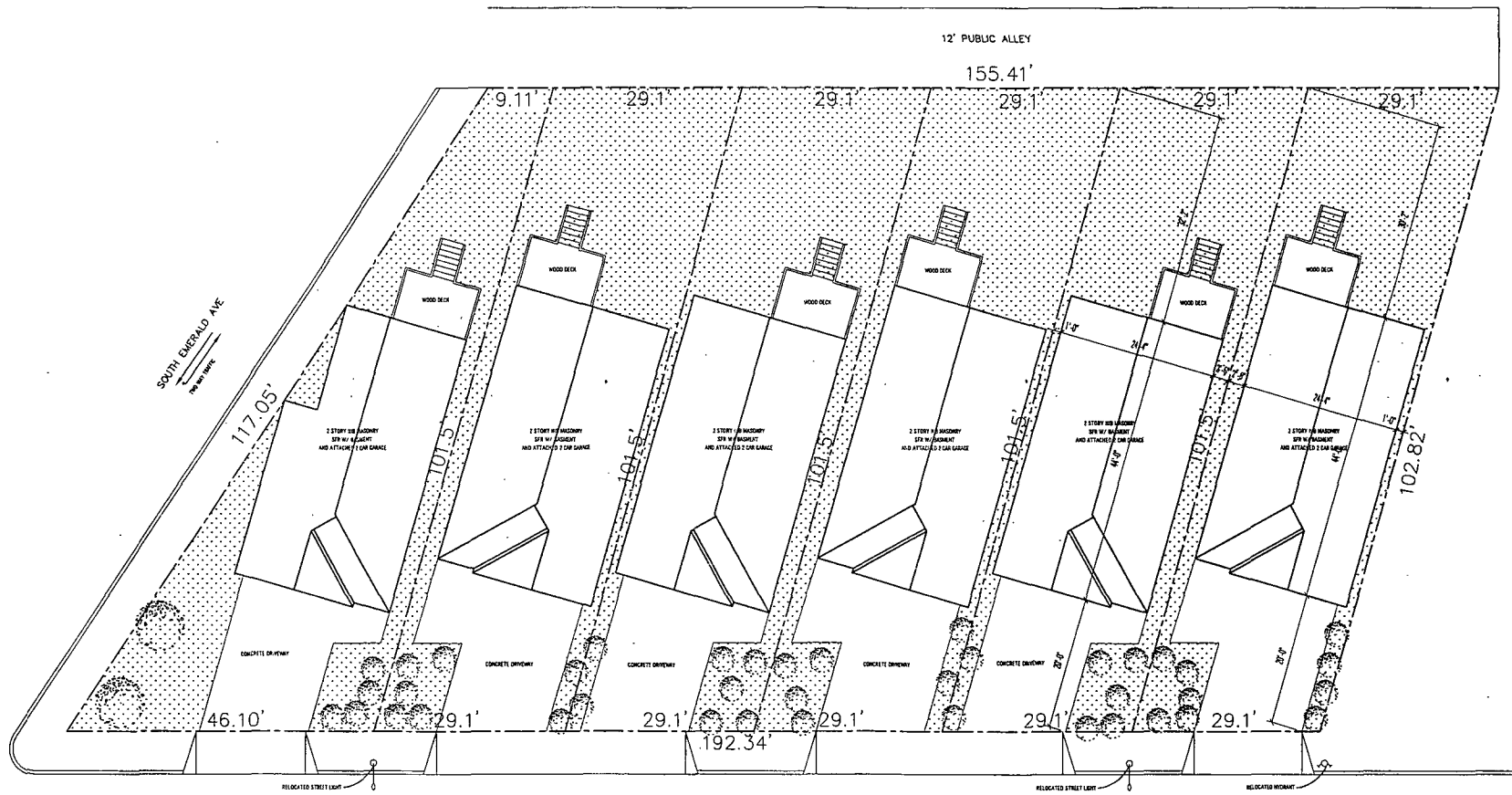

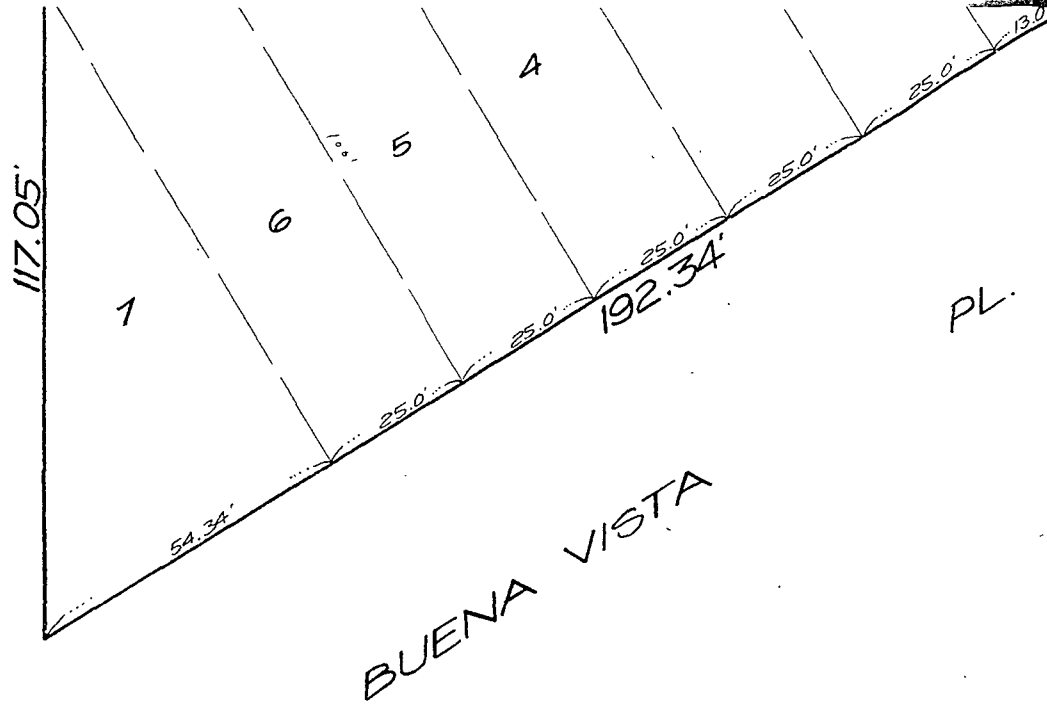

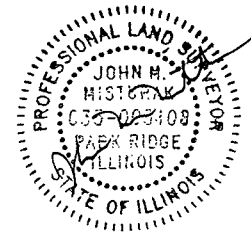
OVERALL SITE PLAN

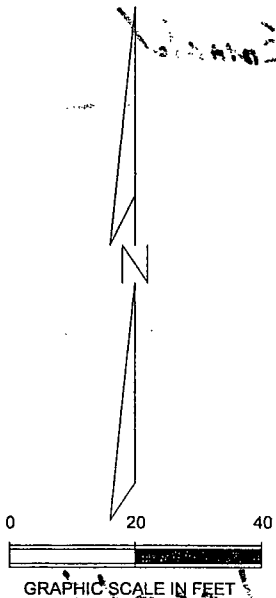
