ORDINANCE LAS TABLAS Acct. No. 293849 - 1 Permit No. 1119802

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to LAS TABLAS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, seven (7) Awning(s) projecting over the public right-of-way adjacent to its premises known as 4920 W. Irving Park Rd..

Said Awning(s) at N. LaPorte measure(s):

One (1) at eight point seven (8.7) feet in length, and one point five (1.5) foot in width for a total of thirteen point zero five (13.05) square feet.

One (1) at seven point seven (7.7) feet in length, and one point five (1.5) foot in width for a total of eleven point five five (11.55) square feet.

Said Awning(s) at WEST IRVING PARK measure(s):

One (1) at nine point four (9.4) feet in length, and one point five (1.5) foot in width for a total of fourteen point one (14.1) square feet.

Two (2) at seven point three (7.3) feet in length, and one point five (1.5) foot in width for a total of twenty-one point nine (21.9) square feet.

One (1) at thirteen point eight (13.8) feet in length, and one point five (1.5) foot in width for a total of twenty point seven (20.7) square feet.

One (1) at four point five (4.5) feet in length, and one point five (1.5) foot in width for a total of six point seven five (6.75) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1119802 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
