

**SECTION 1.** Pursuant to Section 10-20-430 of the Municipal Code of Chicago, the Director of the Department of Revenue is hereby authorized and directed to exempt **3816-20 N Ashland LLC, 2853 N Pulaski # CS** from requiring barriers as a prerequisite to prohibit alley ingress and egress to parking facilities at their property at **3816-20 N Ashland Ave.**
