

The first floor restaurant will be expanded to encompass the entire first floor area of Parcel 1.

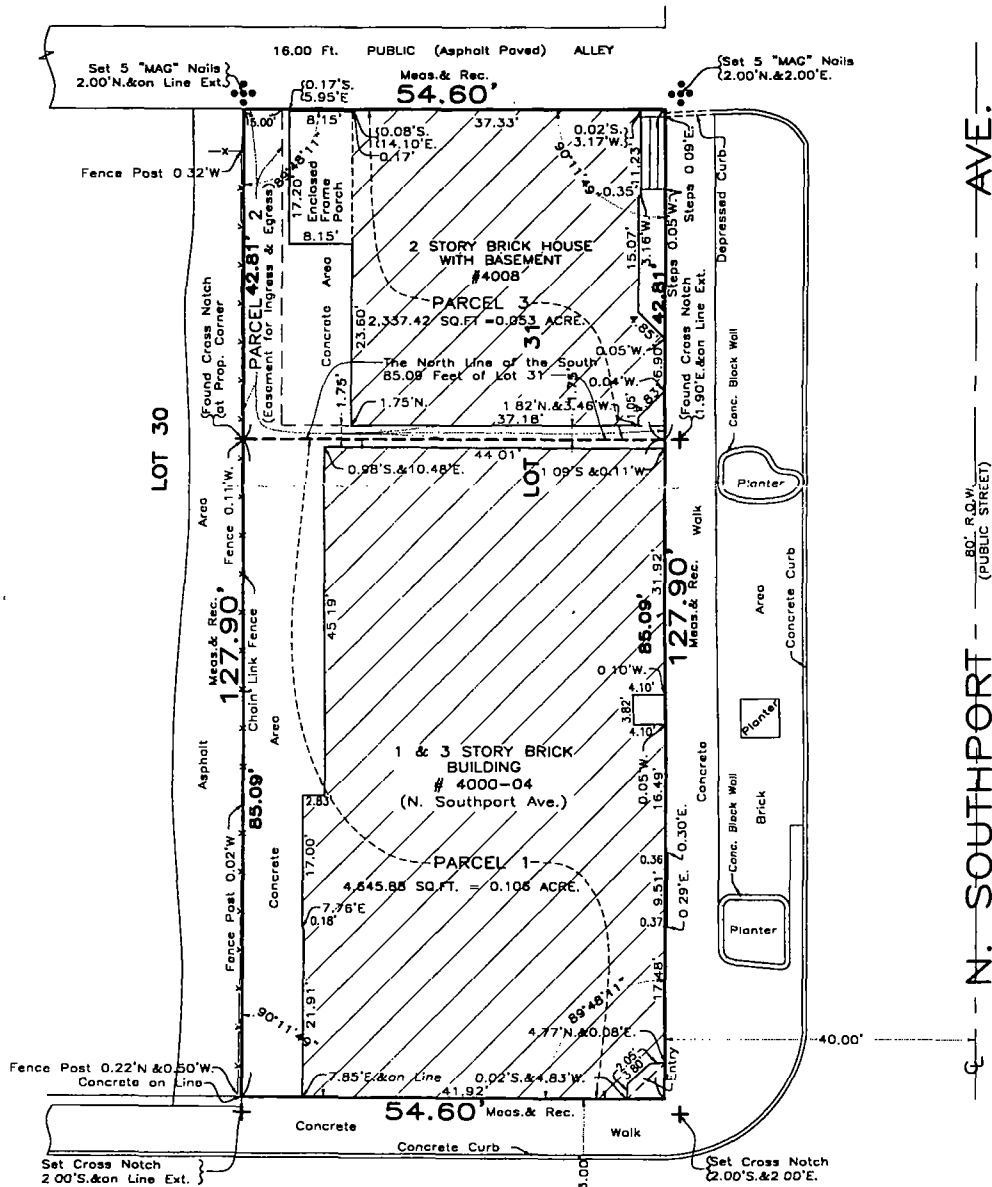
