SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 5-K in the area bound by

a line 291 feet north of and parallel to West North Avenue; North Kildare Avenue; the alley next west of and parallel to North Kildare Avenue; and a line 266 feet north of and parallel to West North Avenue

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


