BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1:

The ordinance passed by the City Council of the City of Chicago for RIVERVIEW TAVERN & GRILL / ROBEY PIZZA on 03/28/2018, and printed upon page 74301 of the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words "RIVERVIEW TAVERN & GRILL / ROBEY PIZZA; Said sidewalk cafe area #1 shall be thirty (30) feet in length and five (5) feet in width, area #2 shall be forty-six (46) feet in length and five (5) feet in width, area #3 shall be fifty (50) feet in length and five (5) feet in width for a total of six hundred thirty (630) square feet; Monday through Saturday 12:00 noon to 12:00 midnight Sunday 12:00 noon to 11:00 p.m. Compensation: \$693.00; SEATING CAPACITY: 68" and inserting in their place the words "THE REVELER; Said area #1 shall be forty-three point two five (43.25) feet in length and five (5) feet in width, area #2 shall be fifty-six point eight three (56.83) feet in length and five (5) feet in width, said area #3 shall be nineteen point one seven (19.17) feet in length and three point five (3.5) feet in width and said area #4 shall be twenty one point eight three (21.83) feet in length and five (5) feet in width for a total of six hundred seventy six point six five (676.65) square feet; Monday through Saturday 10:00 am to 12:00 midnight Sunday 10:00 am to 11:00 pm; Compensation: \$744.31; **SEATING CAPACITY: 97"**
