A line 131.10 feet south of and parallel to East Marquette Road;

The west right-of-way line of the Illinois Central Railroad;

a line 313.10 feet south of and parallel to East Marquette Road;

and South Kenwood Avenue

to those of a B3-1 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
