
To Whom It May Concern:

WHEREAS, Calo Ristorante has been a staple of the Andersonville culinary scene since it opened its doors in 1963; and


WHEREAS, the family-owned and operated business offers an array of Italian and American dishes, including their iconic pizza and BBQ ribs; and
