ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 3-J in the area bounded by:

West Iowa Street; North Harding Avenue; a line 26.79 feet south of and parallel to West Iowa Street; and the public alley next west of and parallel to North Harding Avenue

to those of an B2-3, Neighborhood Mixed-Use District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

856 North Harding Avenue / 3935-45 West Iowa Street

Narrative: The subject property contains 3,348.4 square feet of land and is improved with a two story residential building with four residential dwelling units and a two car garage. The Applicant proposes to rezone the property from a RS-3, Residential Single-Unit (Detached House) District to a B2-3, Neighborhood Mixed-Use District to add two dwelling units for a total of six residential dwelling units on the property. 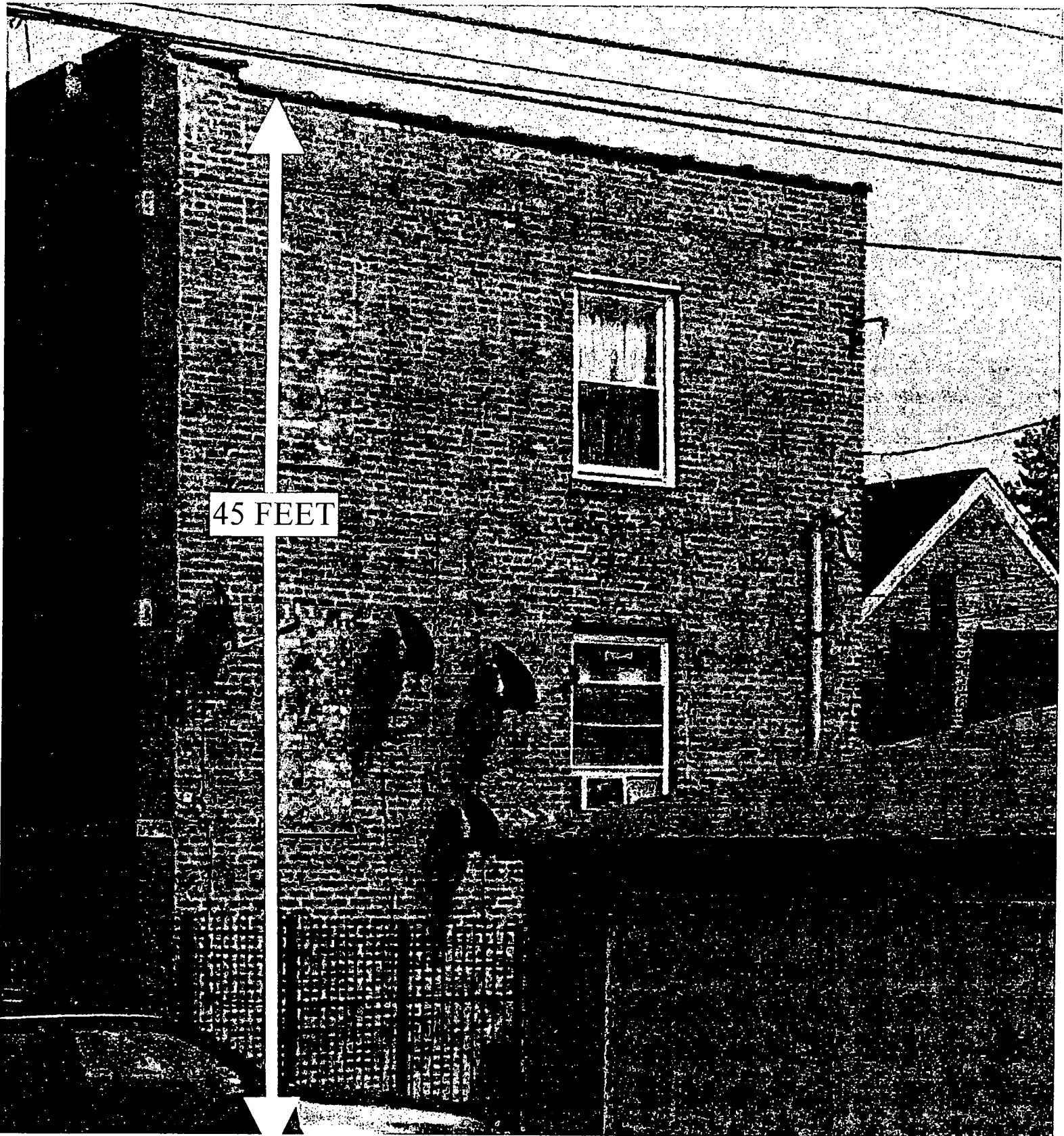
Front/East Elevation



North Elevation

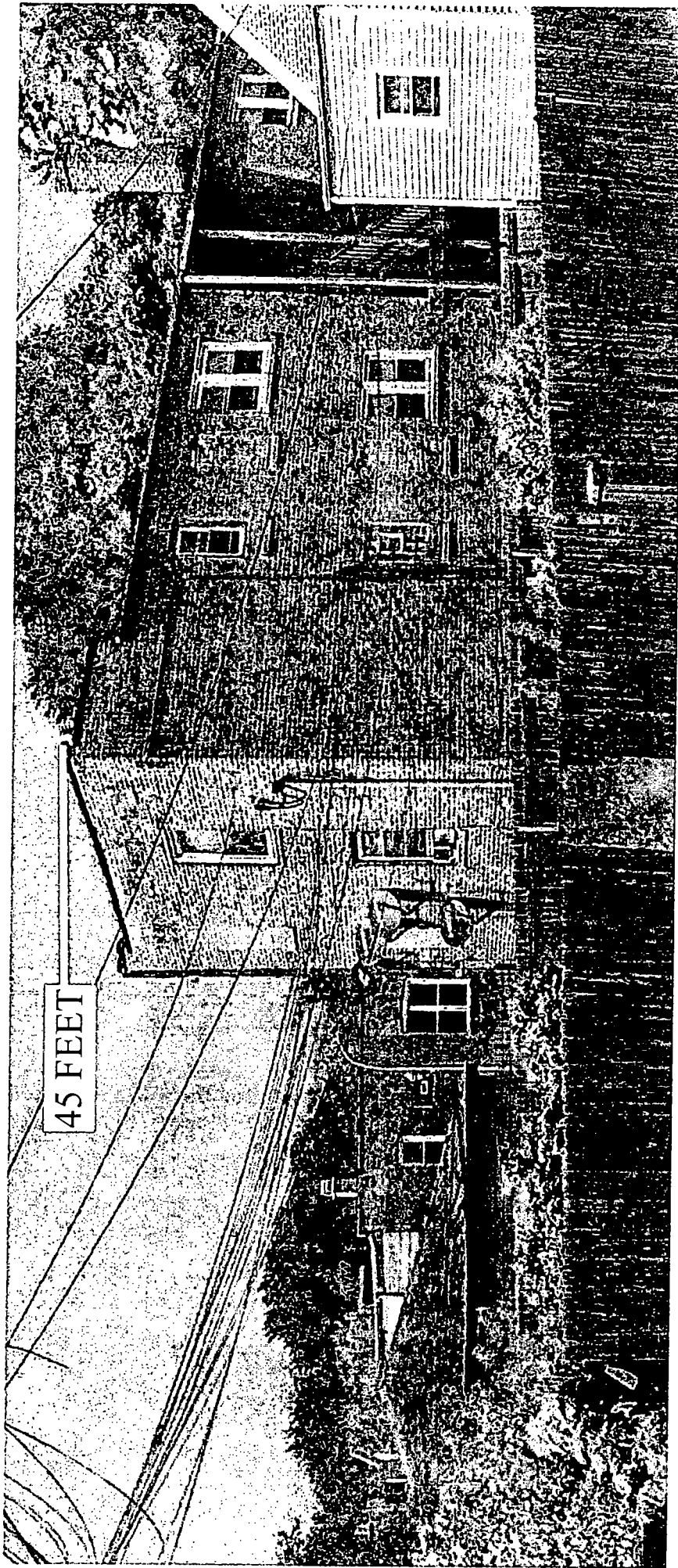


Rear/West Elevation
