**WHEREAS**, Terrence M. Murphy graduated from Loyola University with a degree in history and began his career with the Chicago Bar Association in 1971; and

**WHEREAS**, Terrence M. Murphy worked in a series of management positions before being appointed by the Board on May 23, 1985 to serve as Executive Director and for the past three decades has overseen the growth and vitality of the 22,000-member organization; and

**WHEREAS**, Terrence M. Murphy has held a number of positions outside of the Association, including: Local Bar Delegate; Vice-President and President of the National Association of Bar Executives; founder of the NABE's Minority Committee; Reporting Secretary for the Metropolitan Bar Caucus; member of the Board of Directors of the Chicago Workforce Board; Chair of the Training Subcommittee for the Circuit Court of Cook County's Special Committee on Domestic Violence; and member of the Elmhurst Art Museum's Ethics Committee; and


