RESOLUTION HONORING THE PEGGY AND STEVE FOSSETT FOUNDATION ON THE DEDICATION OF THE STEVE FOSSETT CENTER FOR SCOUTING

WHEREAS, It is the custom of this Legislative body to honor those distinguished individuals and organizations whose work and civic endeavor serve to enhance the quality of life for Chicagoans; and

WHEREAS, Attendant to such concerns, and in full accord with its long-standing traditions, the City Council of Chicago recognizes The Peggy and Steve Fossett Foundation for its generous support and commitment to serving Chicago's youth through its steadfast commitment to the Chicago Area Council of the Boy Scouts of America; and

WHEREAS, In keeping with the goal of providing value-based programs and teaching practical skills, the foundation's support of the Chicago Area Council is helping to prepare tens of thousands of youth for successful, active and happy lives; and
