*Amend Prohibition Of Parking During Specified Hours.*

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That an ordinance passed by the City Council on March 14, 2012 [page 22789 of the Journal of Proceedings], restricting the parking of vehicles except for vendor trucks with permits, on portions of designated streets, be amended by striking:

"N. Stockton Drive (east side) from a point 1045 feet north of W. La Salle Drive to a point 230 feet north thereof - Parking prohibited during specified hours, 5:00 A.M. to 1:00 P.M., Wednesdays and Saturdays, May 15 to November 1, except vendor trucks with permits on N. Stockton Drive

N. Stockton Drive (east side) from a point 720 feet north of W. La Salle Drive to a point 115 feet north thereof - Parking prohibited during specified hours, 5:00 A.M. to 1:00 P.M., Wednesdays and Saturdays, May 15 to November 1, except vendor trucks with permits on N. Stockton Drive

N. Stockton Drive (west side) from a point 1195 feet north of W. La Salle Drive to a point 145 feet north thereof - Parking prohibited during specified hours, 5:00 A.M. to 1:00 P.M., Wednesdays and Saturdays, May 15 to November 1, except vendor trucks with permits on N. Stockton Drive"

And inserting in lieu thereof:

"N. Stockton Drive (east side) from a point 1045 feet north of W. La Salle Drive to a point 230 feet north thereof - Parking prohibited during specified hours, 5:00 A.M. to 1:00 P.M., Wednesdays and Saturdays, May 1 to November 1, except vendor trucks with permits on N. Stockton Drive

N. Stockton Drive (east side) from a point 720 feet north of W. La Salle Drive to a point 115 feet north thereof - Parking prohibited during specified hours, 5:00 A.M. to 1:00 P.M., Wednesdays and Saturdays, May 1 to November 1, except vendor trucks with permits on N. Stockton Drive

N. Stockton Drive (west side) from a point 1195 feet north of W. La Salle Drive to a point 145 feet north thereof - Parking prohibited during specified hours, 5:00 A.M. to 1:00 P.M., Wednesdays and Saturdays, May 1 to November 1, except vendor trucks with permits on N. Stockton Drive"

SECTION 2. This ordinance shall take effect and be in force upon its passage.
